

The following is a summary on the results of the pilot program for the 2016-17 fiscal year.

1. Two (2) tuition assistance awards were provided to teacher assistants in Franklin County Schools during the 2016-17 school year. The recipients of these awards were Ms. Bell and Ms. Coley. Both recipients began their coursework at Vance Granville Community College during Summer 2017. The amount of funds provided in tuition assistance awards for 2016-17 totaled \$1,282.00, with \$796.00 awarded to Ms. Bell and \$486.00 awarded to Ms. Coley. Both tuition assistance awards were based upon coursework taken during Summer 2017.

- 2. The initial tuition assistance awards for both Ms. Bell and Ms. Coley were issued Summer 2017. At this time, neither teacher assistant recipient has achieved teacher licensure. However, both recipients are making satisfactory progress towards completing the required coursework to achieve licensure.
- 3. Both Ms. Bell and Ms. Coley have signed an agreement to remain employed with Franklin County Schools for a minimum of 24 months after receiving a tuition assistance grant.

Franklin County Schools is grateful this opportunity has been made available to our teacher assistants and we are confident that both Ms. Bell and Ms. Coley will make great teachers for our students. Thank you for your support of our school district and public education.

The results of Richmond County School's pilot program for Turning TAs in to Teachers are as follows:

Report for Turning Teacher Assistants into Teachers – Scotland County Schools

Selection Process

Scotland County Schools used the following criteria for selecting the 5 teacher assistant's to participate in the turning TA's to teachers program set force in section 8.29 of the 2016 appropriations bill and updated in 7.20 of the 2017 appropriations bill.

Step 1 – the first three parameters were set forth in the general statue.

- 1. Employment in the eligible LEA/school district.
- 2. Enrolled in an accredited institution of higher education in North Carolina with an educator preparation program approved by the State Board of Education.
- 3. Resident of North Carolina.
- 4. Narrative 750 words describing how the applicant has added value to their school, why the applicant wants to be a teacher, and strengths they would bring to the teaching profession.
- 5. Reference letter from teacher and principal letter shall reflect work done in the school building, attendance, strengths, ability to build relationships, and why they would want the applicant to teach next to them or for them.

<u>Step 2</u> – Top 10 applicants from step 1, Interview process with rubric that focuses on passion for teaching, meeting the needs of all students, ability to build relationships with students and parents, what their potential classroom would look like and experience.

Outcome

Scotland County Schools had 6 teacher assistants apply. All six applicants were selected to participate (5 paid from state funds and 1 paid from local funds). 5 of the teacher assistants started attending UNCP and 1 started to attend St. Andrews in the spring of 2017.
