The Environmental Review Commission will hold a business meeting on Wednesday, August 23, 2017, from 1:30 to 5:00 p. m., at the Andre Mallette Training Center, Human Resources Suite, New Hanover County Government Center, 230 Government Center Drive, Wilmington, North Carolina, to learn about the presence of the GenX compound in the Cape Fear River and its impacts on regional drinking water supplies, and associated regulatory issues.

The meeting agenda will include an opportunity for public comment. In order that their statements may be made a part of the record, speakers are encouraged to provide the Commission with a copy of their prepared remarks at the time of the hearing; however, written remarks are not required.
