#### **EXECUTIVE SUMMARY**

The Inactive Hazardous Sites Program in the Department of Environment and Natural Resources' (DENR) Division of Waste Management (DWM) was created by the North Carolina General Assembly to identify, investigate and cleanup properties contaminated with hazardous substances. Pursuant to G.S. 130A-310.10, the program is required to report to the General Assembly annually. All of the reporting requirements specified under N.C.G.S. 130A-310.10 are met in this report. Since the start of the program in 1987 3,044 chemical spill or disposal sites and old, unlined dumps or landfills (pre-regulatory) that are not being addressed by other environmental authorities have been catalogued. Of this number, 2,592 still require work to address public health or environmental hazards.

Of the 2,592 remaining open cases, 676 are old, unlined landfills that predate solid waste permitting rules. Half of the proceeds of a statewide solid waste disposal tax are directed by statute to the Inactive Hazardous Sites Cleanup Fund for purposes of addressing contamination at these pre-regulatory landfills.

DWM has established contracts with private firms to assess and remediate the pre-regulatory landfill sites. In fiscal year (FY) 2010-11, DWM contractors completed first-phase remedial investigations at 18 sites. DWM has completed the next phase of assessment (delineating the contamination) at 12 sites. An additional 26 first-phase investigations and 24 contaminant delineation investigations were underway in FY 2010-11. DWM also provided oversight and reimbursement for assessment activities undertaken by local governments on old landfill sites (one first phase and three contamination delineation phases). DWM sampled 119 private wells on or near old landfill sites and provided alternate water supplies to four homes that had highly-contaminated wells.

Limited funds are available to assess and remediate non-landfill sites where the owner lacks the financial resources to do it or where the person responsible for the contamination is unknown. The unobligated cash balance in the Inactive Hazardous Sites Cleanup Fund at the end of FY 2010-11 was \$135,806. DWM has estimated the cost of addressing high priority orphan hazardous sites, thus far identified, at \$120,595,206.

The program recovered funds for assessment and remediation through bankruptcy claims for several sites. With the assistance of the Attorney General's Office, the program recovered \$3,750,000 from Chemtura for two sites; \$1,831,982 from Lyondell for four sites; and \$42,738 from Mark IV for three sites. These new monies go into special trust funds, since the payments can only be used on those sites in accordance with the bankruptcy settlement agreements.

The following provides a status report on the Inactive Hazardous Sites Program for the fiscal year.

### I. THE INACTIVE HAZARDOUS SITES INVENTORY AND THE INACTIVE HAZARDOUS WASTE SITES PRIORITY LIST

The Inactive Hazardous Sites Branch in DENR's Division of Waste Management implements the Inactive Hazardous Sites Response Act of 1987 (IHSRA). The IHSRA requires DENR to maintain a catalog of inactive hazardous substance or waste disposal sites. The program has cataloged 2,368 chemical spill sites and 676 old unlined landfills. Of these, 452 sites now have all work completed and are assigned "No Further Action" status. Fourteen completed all work and were assigned "No Further Action" status in FY2010-11. Table 2, on page 4, provides a list of sites assigned "No Further Action" status in FY2010-11. Table 1, on page 2, provides a list of sites added to that inventory since the last program report in October 2010. A total of 68 new sites were added this past fiscal year and seven sites had to be reopened due to new information on contamination.

N.C.G.S. 130A-310.2 requires DWM to prioritize sites catalogued in the Inactive Hazardous Sites Inventory based on the threat to public health and the environment. Sites are first cataloged in the "Evaluations Pending" category of the Inactive Hazardous Sites Inventory until DWM ranks the site based on rules found in 15A NCAC 13C .0200. Once ranked, sites are transferred to the Inactive Hazardous Waste Sites Priority List. The priority list is provided in an appendix to this report organized in order of the threat to public health and the environment. The entire inventory of both ranked and unranked sites can be provided upon request.

### II. SITES THAT MAY OR ARE KNOWN TO REQUIRE USE OF THE INACTIVE HAZARDOUS SITES CLEANUP FUND

#### Purpose of the Fund

The Inactive Hazardous Sites Cleanup Fund is used to: (1) address imminent hazard sites; (2) pay for assessment and cleanup when responsible parties do not comply with orders to clean up sites; (3) pay for assessment and cleanup of sites that do not have financially-viable responsible parties (orphan sites); and (4) pay for state-contracted survey and legal assistance necessary to prepare notices of Inactive Hazardous Substance or Waste Disposal Sites where owners do not comply with orders to conduct such work. The state must attempt to recover its expenditures from responsible parties in the first, second and fourth cases.

The Inactive Hazardous Waste Sites Priority List helps determine priorities for cleanup. Responsible parties for top priority sites are encouraged to voluntarily clean up their sites. When a responsible party does not comply with a request and subsequent order to clean up a site, the state must perform the cleanup using the Inactive Hazardous Sites Cleanup Fund. The demand for state funds to conduct site cleanups depends on two factors: (1) how often responsible parties refuse to comply with orders to conduct cleanup and (2) the number of sites that lack financially-viable responsible parties.

The statute requires that the program report the list of sites known to require funds and the list of sites suspected to require funds for cleanup. Determining whether a responsible party exists (and thus, whether state funds will be needed for assessment and cleanup) is often a complex and lengthy process. It is also difficult to keep this information updated as owners and operators of the facilities change over time. To avoid the need to update the information several times, DWM does responsible party research when a site is next in priority for action.

#### Orphan Chemical Sites

The Inactive Hazardous Sites Cleanup Fund was used to address several sites this year. A summary of the work is provided in Table 3.

DENR has also recovered some funds to address specific sites through bankruptcy claims. The following summarizes work activities in FY 2010-11 using bankruptcy funds:

- **Burlington Industries** Approximately \$465,000 was obtained in 2007 through a claim for six Burlington Industries properties. While the amount of funds is limited, the funds were used to remove sources of contamination, thereby reducing the further spread of groundwater contamination and encouraging natural attenuation processes. A total of \$8,961 remained that was not sufficient to conduct any further meaningful work at the Burlington sites. Our bankruptcy settlement agreements allow that in such a situation, the residue can be spent on other orphan Inactive Hazardous Sites.
- Chemtura Corporation A total of \$3,750,000 was recovered in November 2010 for cleanup of the Crompton and Knowles site in Lowell and the Leesona site in Burlington. Work is pending.
- **CMI** \$1,250,000, \$750,000 and \$100,000 have been recovered for three CMI sites. These funds have been used to conduct assessment at three CMI sites in Elkin. \$258,352, \$42,068, and \$32,660 remain, respectively, for each site. Cleanup activities are ongoing.
- **Lyondell** A total of \$1,831,982 was recovered through bankruptcy in March 2011 to address four sites: two Cherokee Resources sites in Charlotte, SCM Proctor-Silex in Mt Airy, and SCM Proctor-Silex in Southern Pines. Appropriate distribution of expenditures is being evaluated across these sites based on risk posed and feasibility of remedies.
- Mark IV A total of \$42,738 was recovered for three Dayco Inc sites in Haywood County. Work is pending.
- **Pillowtex** A total of \$210,000 has been recovered to address the Fieldcrest Mills site in Spencer and the Cannon Mills site in Kannapolis. There is a small possibility of additional payout from this bankruptcy, which could provide some additional revenue. DENR is evaluating where best to spend funds at these two sites.
- SCM \$5.3 million was obtained to address the SCM site in Charlotte. The funds are held in a private trust fund. The trustee contracts the work at DENR's direction. Work is ongoing.
- **Texfi, Inc.** DENR recovered approximately \$940,000 in funds through a bankruptcy claim against Texfi, Inc., that is being used to remove sources of contamination at the Fayetteville property. A total of \$173,001 remains. Work is continuing.

#### Pre-Regulatory Landfills

Senate Bill 1492, enacted in 2007, established a state-wide tax on solid waste disposal, half of which goes to address the hazards posed by landfills that predate federal and state rules on solid waste disposal. The provisions of the bill that relate to the assessment and abatement of contamination at these pre-regulatory landfills went into effect in July 2008. The Division of Waste Management received the first proceeds of the tax in February 2009.

DWM has cataloged a total of 676 unpermitted, unlined landfills. Initial work at each site involved confirming the location, determining the current use of the property, and identifying the use of surrounding property (for example, residential or commercial) to help prioritize the sites for action. That work has been completed. The division then established contracts for contaminant assessment and mitigation of the sites and this work has begun. The division has also provided review/and approval of assessment work being conducted by local governments and reimbursed the cost of that work from the tax proceeds.

In FY 2010-11, DWM completed first phase remedial investigations (access, updated receptor research, geophysical assessment to define perimeter of the waste) at 18 sites. DWM completed the second phase of assessment (delineation of the extent of the contamination on the site) at 12 sites. An additional 26 first phase investigations and 24 contaminant delineation investigations were underway in FY 2010-11. DWM also provided oversight for local government assessments (one first phase and three contaminant delineation phase assessments) that were completed and approved for reimbursement. The program also sampled 119 private water supply wells on or near unpermitted landfills and provided alternate water supplies to four homes that had high levels of contamination. Thirty-nine new sites were screened for program qualification. Of those, nine new sites were added to the program catalog.

The program also oversaw a study conducted by NC State University students to determine if former landfills may be candidate sites for solar power farms. The project compiled information on the likelihood of each site as a candidate using geographic information systems. The project has received the attention of potential developers.

Due to budget constraints and less tax revenue than had been originally anticipated, there has been a delay in filling the seven positions needed to implement the program. However, three more positions were filled this year, for a current total of six.

#### Cleanup Funds Needed

Currently 372 sites, of which 214 are higher-priority cases, have been identified that have no financially-viable responsible parties and require further action. As explained earlier in this chapter, the total number of orphan sites is not presently known.

Orphan site work can include assessment only, small-to-large soil and waste cleanup, water line installation or larger groundwater restoration projects. An average cost-per-site was determined by first calculating the average cost for orphan soil cleanup actions conducted by DENR's Inactive Hazardous Sites Branch and averaging that figure with an average site cleanup cost for several state programs published by the Association of State and Territorial Solid Waste Management Officials, adjusting for inflation. That figure comes to \$563,529 per site. The total

cost for cleanup is estimated to be \$209,632,788 for 372 orphan sites or \$120,895,206 for higher-priority orphan sites. (See the table on page 29.)

As of July 1, 2011, the balance of the Inactive Hazardous Sites Cleanup Fund totaled \$618,808. Of this, \$173,001 is bankruptcy proceeds dedicated to conducting contaminant source remediation at the Texfi-Fayetteville site. Of the remaining \$445,807, \$257,347 is currently obligated in contracts for assessment and cleanup of the sites. On average, the amount of revenue deposited into the Fund each year is around \$385,000. The fact that the "unobligated" cash balance is \$135,806 and the amount of revenue generated each year for the fund is only \$385,000, clearly points out that the Inactive Hazardous Sites Cleanup Fund is underfunded to address inactive site remediation across the state.

#### III. NATIONAL PRIORITIES LIST SITES REQUIRING A STATE COST SHARE

National Priorities List (NPL) sites are those hazardous substance or waste disposal sites that are priorities for cleanup under the federal Comprehensive Environmental Response, Compensation and Liability Act (CERCLA), more commonly known as Superfund. These are sites identified by the United States Environmental Protection Agency (EPA) as high priorities for environmental cleanup because of the nature of the contamination and actual or potential threat to human health and the environment. North Carolina has 36 NPL sites.

The NPL includes both sites with financially-viable responsible parties and orphan sites. Cleanup costs are financed either by responsible parties or by a federal trust fund with a state cost share. When the federal trust fund is used, CERCLA requires North Carolina to pay 10 percent of the cleanup cost plus 100 percent of the cost to operate and maintain the remediation system.

Table 4 provides a list of the North Carolina NPL sites and the following information for each site: location, investigation/cleanup status, estimated costs, and projected start dates for cleanup. Part I of Table 4, found on page 12, includes those sites where the Federal Trust Fund/North Carolina cost share is required. A summary of North Carolina's cost share obligations is provided at the end of this part. Part II of Table 4, found on page 14, includes the status of responsible party funded cleanups.

#### IV. RESPONSIBLE PARTY VOLUNTARY SITE REMEDIAL ACTION

When the Inactive Hazardous Sites Branch requests a person responsible for contamination to take action at a priority site, most agree to voluntarily conduct a cleanup. In addition to voluntary actions at the request of the program, responsible parties and owners often initiate an approved assessment and/or remedial action on their own. Due to the number of volunteers and very limited staff resources, the General Assembly has authorized DENR to privatize the program's oversight of voluntary remediation activities at lower priority sites. DWM continues to provide oversight for assessment and remediation at sites that present more severe public health threats or other concerns.

The privatized portion of the voluntary cleanup program is called the Registered Environmental Consultant (REC) Program. Under this program, a responsible party hires a private consultant to conduct the site assessment and cleanup and to certify that those activities comply with regulations. The REC certification replaces state oversight of the assessment and cleanup. For a firm to qualify as a REC, it must meet certain qualifications. The state audits a number of the REC projects each year to ensure the integrity of the program. DWM has the authority to sanction an REC where necessary. State staff auditors are funded through fees collected from the voluntary participants.

A current list of the 126 sites where assessments and cleanups are underway in accordance with an administrative agreement with the state is provided in Table 5 on the following page. These are a mixture of REC-directed and DENR-directed actions. Table 6, found on page 21, is a list of additional DENR-directed responsible party assessment and cleanup actions not under administrative agreements.

Their location, a site description, status and funding source are also provided.

### **Additional Funds from Bankruptcy Proceedings**

With the assistance of the Attorney General's Office, DWM has recovered funds for assessment and remediation of 16 sites through bankruptcy proceedings. Payments out of a bankruptcy

proceeding must go into a special trust account to be used only for the specific sites identified in the bankruptcy settlement agreement. Funds recovered through bankruptcy proceedings include the following:

**Pillowtex** -- \$210,000 for two former Pillowtex sites.

**SCM** -- \$5.3 million for the SCM Corp site in Charlotte.

**CMI** -- \$1,250,000, \$750,000 and \$100,000 recovered for three CMI sites. \$258,352, \$42,068, and \$32,660 remain, respectively, in each account.

**Safety-Kleen** -- \$654 has been deposited in the Inactive Hazardous Sites Cleanup Fund.

**Chemtura** -- \$3,750,000 for two sites

**Lyondell** -- \$1,831,982 for four sites

Mark IV -- \$42,738 for three sites.
