#### **BACKGROUND INFORMATION:**

The Environmental Review Commission (ERC) is an entity of the General Assembly of North Carolina. The ERC is established by G.S. 120.70-41 et seq. to serve as the principal legislative entity responsible for legislative oversight and study of matters related to protection of the environment and conservation of natural resources. (Note that the ERC is a separate entity from the Environmental Management Commission (EMC), which is an executive branch agency within the Department of Environment and Natural Resources (DENR) responsible for implementation of various environmental laws.)

Section 1.(a) of S.L. 2007-518 (H.B. 820), which was enacted by the 2007 Regular Session of the General Assembly directs the ERC, with the assistance of DENR, to study the allocation of water resources and their availability and maintenance in the State. The ERC entered into a contract with the Institute of Government at the University of North Carolina at Chapel Hill for significant portions of the study. In its work on the study, the Institute of Government subcontracted with the Nicholas Institute for Environmental Policy Solutions at Duke University. **Richard Whisnant**, Associate Professor of Public Law and Government at the Institute of Government, and **Bill Holman**, Visiting Senior Fellow at the Nicholas Institute, are the **Principal Investigators** for the study. Mr. Whisnant and Mr. Holman presented the draft Water Allocation Study Report to the ERC on 25 November 2008.

Written comments should be submitted on standard size (8½" x 11") paper with sufficient margins for binding.

AN ACT TO DIRECT THE ENVIRONMENTAL REVIEW COMMISSION TO STUDY ISSUES RELATED TO THE TRANSFER OF WATER FROM ONE RIVER BASIN TO ANOTHER RIVER BASIN AND THE ALLOCATION OF SURFACE WATER RESOURCES AND TO AMEND THE LAWS GOVERNING THE TRANSFER OF WATER FROM ONE RIVER BASIN TO ANOTHER RIVER BASIN.

The General Assembly of North Carolina enacts:

**SECTION 1.(a)** The Environmental Review Commission, with the assistance of the Department of Environment and Natural Resources, shall study the allocation of surface water resources and their availability and maintenance in the State, including issues related to the transfer of water from one river basin to another, the withdrawal of water for consumptive use, and the accuracy and tolerance of equipment used to measure the flow of water transferred from one river basin to another river basin. The Commission shall evaluate the benefits of establishing formal and informal procedures for negotiating transfers of water from one river basin to another. The Commission shall also study and recommend measures to: (i) ensure that the purposes of the Regional Water Supply Planning Act of 1971, as set out in G.S. 162A-21, are fulfilled; (ii) provide for a comprehensive system for regulating surface water withdrawals for consumptive and nonconsumptive uses; (iii) provide for the establishment of a statewide plan for water resources development projects; (iv) provide for adequate resources for the Department so that it may develop and implement a comprehensive approach to water resources management; (v) ensure that all State laws regulating water resources are consistent with and fully integrated into the comprehensive system for regulating surface water withdrawals and the statewide plan for water resources development projects; and (vi) ensure that potential interstate conflicts related to water resources are avoided or minimized. In the conduct of this study, the Environmental Review Commission may employ independent consultants as provided in G.S. 120-32.02 and G.S. 120-70.44. The Environmental Review Commission may submit an interim report to the 2008 Regular Session of the General Assembly and shall submit a final report of its findings and recommendations, including any legislative proposals, to the 2009 General Assembly.

**SECTION 7.(a)** Except as provided in subsection (b) of this section, this act becomes effective when it becomes law and applies to any petition for a certificate for a transfer of surface water from one river basin to another river basin first made on or after that date.

AN ACT TO EXTEND THE STUDY OF THE ALLOCATION OF WATER RESOURCES AND THEIR AVAILABILITY AND MAINTENANCE IN THE STATE, AS RECOMMENDED BY THE ENVIRONMENTAL REVIEW COMMISSION.

Whereas, the Environmental Review Commission and the University of North Carolina at Chapel Hill School of Government acknowledge that an extension of time is necessary in order to complete the work of the Water Allocation Study contemplated in the contract between the two parties and the work identified in Section 1(a) of S.L. 2007-518; and

Whereas, the University of North Carolina School of Government acknowledges in its Interim Report to the Environmental Review Commission that further work will be required beyond 2008 given the scope and importance of the study; Now, therefore,

The General Assembly of North Carolina enacts:

**SECTION 1.** Section 1(a) of S.L. 2007-518 reads as rewritten:

"SECTION 1.(a) The Environmental Review Commission, with the assistance of the Department of Environment and Natural Resources, shall study the allocation of surface water resources and their availability and maintenance in the State, including issues related to the transfer of water from one river basin to another, the withdrawal of water for consumptive use, and the accuracy and tolerance of equipment used to measure the flow of water transferred from one river basin to another river basin. The Commission shall evaluate the benefits of establishing formal and informal procedures for negotiating transfers of water from one river basin to another. The Commission shall also study and recommend measures to: (i) ensure that the purposes of the Regional Water Supply Planning Act of 1971, as set out in G.S. 162A-21, are fulfilled; (ii) provide for a comprehensive system for regulating surface water withdrawals for consumptive and nonconsumptive uses; (iii) provide for the establishment of a statewide plan for water resources development projects; (iv) provide for adequate resources for the Department so that it may develop and implement a comprehensive approach to water resources management; (v) ensure that all State laws regulating water resources are consistent with and fully integrated into the comprehensive system for regulating surface water withdrawals and the statewide plan for water resources development projects; and (vi) ensure that potential interstate conflicts related to water resources are avoided or minimized. In the conduct of this study, the Environmental Review Commission may employ independent consultants as provided in G.S. 120-32.02 and G.S. 120-70.44. The Environmental Review Commission may submit an interim report reports to the 2008 and 2009 Regular Session regular sessions of the General Assembly and shall submit a final report of its findings and recommendations, including any legislative proposals, to the 2009 General Assembly on or before 1 October 2010."

SECTION 2. This act is effective when it becomes law. In the General Assembly read three times and ratified this the 16<sup>th</sup> day of June, 2008.
