You are reminded that the Coastal Stormwater Rules Working Group (CSRWG) will meet at **2:00pm on Thursday 22 May 2008 in Room 544 of the Legislative Office Building in Raleigh**. At this meeting, the Department of Environment and Natural Resources (DENR) will present proposed changes to the coastal stormwater rules that are intended to address many of the concerns that have been identified to date. We anticipate that the working group will review these proposals and will consider how to proceed towards a resolution of the remaining concerns. We regret that we are unable to distribute the DENR proposals in advance.

We anticipate that the next meeting after the 22 May meeting will be held at 2:00 p.m. on Thursday 29 May 2008.
