N.C. Mining and Energy Commission And Department of Environment and Natural Resources Quarterly Report on Activities Conducted Pursuant to S.L. 2012-143 To the Joint Legislative Commission on Energy Policy And the Environmental Review Commission July 1, 2014

Session Law 2012-143, the Clean Energy and Economic Security Act, was ratified on July 2, 2012 and reconstituted the North Carolina Mining Commission as the North Carolina Mining and Energy Commission. The Act directs the Mining and Energy Commission (MEC) to establish a modern regulatory program for the management of oil and gas exploration and development in the State and the use of horizontal drilling and hydraulic fracturing treatments involved for that purpose. The Act directs the Commission to submit quarterly written reports on the Commission's operation, activities, programs, and progress to the Joint Legislative Commission on Energy Policy and the Environmental Review Commission (Section 1.(h)). The Department is also required to report on the progress in developing and adopting the rules required to be adopted by S.L. 2012-143. The quarterly reports shall include recommendations on changes required to existing rules and statutes and any other findings or recommendations necessary for the implementation of the Act (Section 2.(m)). This report satisfies both of these reporting requirements for the April through June 2014 timeframe.

Activities for each of the MEC Committees for this quarter are summarized below:

The **Administration of Oil and Gas Committee** convened on April 3, 2014 and deliberated, approved, and formally passed the following draft rules to the Rules Committee:

- Draft Financial Assurance rules, which establish requirements for financial assurance related to well plugging and abandonment and site reclamation;
- Draft Reclamation rules, which address requirements for final land surface restoration; and
- Draft Drilling Unit rules, which establish standards for combining contiguous properties into oil or gas drilling units.

No other Administration of Oil and Gas Committee meetings were held during this quarter due to this Committee's completion of initial rule assignments.

The **Environmental Standards Committee** did not meet during this quarter due to its completion of initial rule assignments.

The **Water and Waste Management Committee** did not meet during this quarter due to its completion of initial rule assignments.

The **Rules Committee** convened on April 3, 2014 and extended its discussions into April 4, 2014. During this meeting, the Committee deliberated, approved, and formally passed the draft Financial Assurance, draft Reclamation, and the draft Drilling Unit rules to the Mining and Energy Commission. The Rules Committee also deliberated and approved the Draft Permitting rules setting requirements for an oil or gas operator to apply for and obtain a permit to drill an oil or gas well. Finally, the Committee began discussions to consider the draft Administrative Rule Set, to establish requirements for MEC functional procedures as delineated under the following rule subsets:

• Draft Civil Penalty Rule, for assessing fines and handling Attorney General referrals;

- Draft Declaratory Ruling Rule allowing for the MEC to address requests to reconsider interpretation or application of oil and gas rules;
- Draft Enforcement Rule, for issuing Notices of Violation, assessing penalties, permit suspensions or revocations, etc.;
- Draft Hearings Rule, for holding public hearings and for designating hearing officers;
- Inspections Rule, for allowing DENR to inspect well sites and related records;
- Draft Petition for Rule Making Rule, for handling requests to the MEC for the development of new rules or modifying existing rules; and
- Draft Variance Rule, for the requesting and granting of variances to oil and gas rule requirements.

The final meeting of the Rules Committee occurred on April 15, 2014, wherein Committee members approved the draft Administrative Rule Set and formally passed it to the MEC.

The **Mining Committee** did not meet during this quarter.

Study Groups of the Mining and Energy Commission

Study Groups did not meet during this quarter. However, the **Funding Levels and Potential Funding Sources Study Group** submitted the addendum to its initial October 1, 2013 report to the Legislature on April 1, 2014. The Study Group provided the addendum in response to Session Law 2013-365, which required the Mining and Energy Commission to "...formulate recommendations for appropriate levels of funding that should be maintained to address emergency events associated with oil and gas exploration, including sufficient funding for emergency preparation, emergency response, emergency environmental protection, or mitigation associated with a release of liquid hydrocarbons or associated fluids directly related to onshore energy exploration, development, production, or transmission." As a result of this charge, the Study Group considered and developed recommendations for the following matters:

- Funding for emergency response operations, specifically to address well blowouts; and
- Funding for long-term contaminant release mitigation.

The Funding Levels and Potential Funding Sources Study Group researched legal agreements between oil and gas operators and well blowout mitigation companies, financial assurance strategies, and the environmental response and contaminant mitigation programs currently operating within the NC Division of Waste Management. Recommendations include requirements for oil and gas operators to maintain contracts with well blowout and mitigation contractors, as well as providing funding via severance taxes to the Division of Waste Management.

The **Mining and Energy Commission** held three meetings during this quarter. During the January 14, 2014 meeting, the Commission deliberated and passed the following draft rule sets and assigned them to staff for internal completion:

- Draft Drilling Unit Rule;
- Draft Reclamation Rule:
- Draft Financial Assurance Rule;
- Draft Well Stimulation Rule;
- Draft Permitting Rule;
- Draft Waste Management Rule; and
- Draft Administrative Rules.

The next meeting of the Mining and Energy Commission occurred on May 15, 2014 and extended through May 16, 2014. During this meeting, the Commission accepted and deliberated the draft 15A NCAC 05H "Oil and Gas Conservation" Rules, which constituted the compilation of all draft rules. Commissioners provided feedback which staff used to update the draft rule bundle for the June 5 and 6, 2014 meeting.

The final meeting of the Mining and Energy Commission occurred on June 5, 2014 and extended through June 6, 2014. Commissioners continued deliberation of the draft 15A NCAC 05H Rules, which included modifying a few of the rules to comply with the Energy Modernization Act, Session Law 2014-4, which was signed into law by the Governor just two days earlier- on June 4, 2014. The MEC voted to approve the Draft Oil and Gas Conservation Rules for release to the NC Register and submission for public comment, pending staff edits based on Commission input. On completing its rulemaking business, the MEC voted its new slate of officers for 2014-15. Dr. Vikram Rao was selected by acclimation to serve as Chairman of the MEC and Ms. Amy Pickle was selected by acclimation to serve as Vice Chair of the commission. Terms of office for both will begin on August 1, 2014 and end with the statutory termination of the MEC on July 31, 2015.

The Division of Energy, Mineral and Land Resources (DEMLR) Oil and Gas Program personnel completed rule edits and have submitted 15A NCAC 05H to the Office of Administrative Hearings for publication in the NC Register and for solicitation of public comment.

MEC Commissioners continue to participate in local and regional education and outreach programs, in addition to providing information briefings to the Legislature. Specific activities for this quarter included:

- April 1, 2014: MEC Chairman James Womack gave a presentation at the Joint Legislative Commission on Energy Policy, providing a general update on MEC rule development timeline and upcoming milestones;
- April 17, 2014: MEC Chairman James Womack presented an overview of rulemaking and the prospects for shale-derived energy development to the Advanced Energy Organization during a retreat in Duck, NC.
- April 22, 2014: Commissioners Dr. Kenneth Taylor, Dr. Vikram Rao, and Ms. Jane Lewis-Raymond participated on the "Oil and Gas Exploration and Development" panel for the annual North Carolina Sustainable Energy Conference in Raleigh, NC;
- April 22, 2014: MEC Chairman James Womack, along with Commissioners Ms. Amy Pickle, Dr. Kenneth Taylor, and Dr. Ray Covington participated on the "Oil and Gas Rule Development and Statutory Considerations" panel for the annual North Carolina Sustainable Energy Conference in Raleigh, NC;
- April 24, 2014: Commissioner and State Geologist Dr. Kenneth Taylor provided a
 presentation at the NC Emergency Operations Center to the Hazmat Regional
 Response Team Advisory Council. Discussion topics included well stimulation, chemical
 disclosure, and emergency response notification requirements as delineated within the
 draft Oil and Gas rules; and
- May 8, 2014: MEC Chairman James Womack made a presentation on shale energy rulemaking and development to the Anderson Creek Owners' Association in southern Harnett County.

DEMLR staff also participated in local and regional education and outreach programs. On April 26, 2014, staff provided presentations on North Carolina geology, hydrocarbon resources, and the current progress of rule development to members at the Moravian Environmental Stewardship Conference's weekend retreat in Laurel Springs, NC. Staff also participated in as

both a moderator and in a panel member role along with Commissioners during the April 22-23, 2014 North Carolina Sustainable Energy Conference in Raleigh.

Oil and Gas Program personnel continue to assist the North Carolina Geological Survey (NCGS) in assessing hydrocarbon potential and have helped with rock sample processing, data compilation and plotting, and the technical review of professional conference posters. Additionally, staff teamed with NCGS to set up a booth to advertise North Carolina resources and to network with industry professionals during the North American Prospect Expo in Pittsburgh, PA from April 9-11, 2014.

MEC Appointments

At the end of June 2014, Commissioner Charles Holbrook's term on the MEC will expire. He has been a vitally important oil and gas geologist whose leadership on the Administration of Oil and Gas Committee was instrumental in the commission completing its first set of MEC rules. Unfortunately, Mr. Holbrook is not seeking reappointment. Speaker Tillis' office is in the process of naming a replacement for him by the end of the month.

Likewise, Mr. Ivan "Tex" Gilmore's term on the MEC expires at the end of June, 2014. President Pro Tem of the Senate Berger is in the process of reappointing Mr. Gilmore, and we anticipate completion of that action by the end of June.

Dr. Marva Price's is similarly scheduled to complete her term on the MEC at the end of June 2014. She has indicated her willingness to continue serving the commission as the Governor's appointed representative of the Public Health Commission. In coordination with the Governor's office, it appears they do not have an immediate replacement for Dr. Price, so she will continue serving the MEC on a month-to-month basis until or unless a replacement is named.
