Durham County Engineering and Environmental Services Pretreatment Program Authorization to Construct Review Procedures

- 1. Compliance Manager receives PE sealed and signed construction plans and specifications and any applicable fees.
- Compliance staff reviews submittals and prepares either a request for additional information or an approval letter. Additional information letters are to specify the issues based on one of three conditions:
 - a. Incomplete submittal,
 - b. Regulation, statute, or ordinance, or
 - c. Design/function suggestions.
- 3. For resubmittals, compliance staff shall determine if the issues have been resolved. If the issues are not resolved, compliance staff shall issue a second additional information letter specifying the issues based on one of three conditions:
 - a. Incomplete submittal,
 - b. Regulation, statute, or ordinance, or
 - c. Design/function suggestions.

The second additional information letter shall be addressed to the user and copied to the design consultant. The letter shall provide information regarding an informal review process with the Utility Division Manager/POTW Director who is also a registered NC Professional Engineer.

4. For the second resubmittal, compliance staff and the Utility Division Manager shall review the submittal. If the submittal is found to be deficient, it shall be denied. The denial letter will specify the Adjudicatory Hearing procedures of Durham County Section 26-132 (9).
