SESSION LAW 2014-120, SECTION 29, "REFORM AGENCY REVIEW OF ENGINEERING WORK"

Session Law 2014-120, Section 29 (link to full text of Law) requires certain administrative changes be implemented by any unit of local government operating a program (i) that grants permits, licenses, or approvals to the public and (ii) that is either approved by or delegated from the Department of Environment and Natural Resources or the Department of Health and Human Services.

The following City Ordinances enforced by the Land Development Division are deemed to have been "either approved by or delegated from" NCDENR and thereby subject to the provisions of Section 29 of the Session Law:

- Post-Construction Stormwater Ordinance (City Code Chapter 18, Article IV)
- Soil Erosion and Sedimentation Control Ordinance (City Code Chapter 17)
- Zoning Ordinance Watershed Overlay Districts for Mountain Island Lake & Catawba River/Lake Wylie (City Code Appendix-A, Chapter 10, Part-5 & Part-6)

The following administrative changes have been implemented in response to the Session Law:

- 1) Per Section 29.(b) of the Session Law, the Land Development Division has adopted the following conventions for review comments:
 - Review comments associated with the Post-Construction Stormwater Ordinance will begin with "PCO"
 - Review comments associated with the Soil Erosion and Sedimentation Control Ordinance will begin with "EC"
 - Review comments associated with the Zoning Ordinance Watershed Overlay Districts for Mountain Island Lake & Catawba River/Lake Wylie (City Code Appendix-A, Parts 5 & 6) will begin with "WATERSHED"
 - All review comments are requirements unless the comment begins with "RECOMMENDATION".

(Please note: The reference to a particular ordinance also includes by reference all adopted design manuals, administrative manuals, standard details and specifications.)

- 2) Per Section 29.(c) of the Session Law, the Land Development Division has established an Informal Review process with respect to the City Ordinances identified above for the following circumstances:
 - The inclusion in a Regulatory Submittal of a design or practice sealed by a Professional Engineer but not included in the Regulatory Authority's existing guidance, manuals, or standard operating procedures.
 - A disagreement between the reviewer of the Regulatory Submittal and the Submitting Party
 regarding whether the statutory or regulatory authority identified by the Regulatory Authority for
 revisions or requests for additional information designated as "required" justifies a required change.

Any Submitting Party desiring an Informal Review under the preceding circumstances should download the Informal Review Request form found on the Development Services web page (<u>link to web page, see "NEWS" section</u>) and email the completed form to David Weekly, PE, Land Development Division Manager.

3) Per Section 29.(h) of the Session Law, non-licensed plan review engineers in the Land Development Division will now use the Working Job Title "Plan Reviewer" in all public correspondence.
