Orange Water and Sewer Authority

<u>Response and Implementation of Procedures to Address S734 [Ratified], Section 29 Reform</u> <u>Agency Review of Engineering Work - Initial Report</u>

The Orange Water and Sewer Authority engineering department staff review extensions of public water and sanitary sewer mains within its distribution and collection system to ensure compliance with the standards, specifications, policies, and procedures of OWASA and laws of the State of North Carolina. This involves communicating with and providing plan review comments and correspondence with developers, engineers, Towns and other entities. Once the submitting party satisfactorily addresses regulatory review comments, acquires necessary approvals and permits, OWASA staff will issue a permit to construct the utility improvements.

Section 29.(b) Standardization and Review of Regulatory Review Process:

- (1). Regulatory review comments provided during review of submittals already distinguishes between what are comments that are 'recommendations or suggestions' and those that are mandatory. In such cases, verbiage in the review comments includes a statement such as: 'We recommend' or 'we suggest' as opposed to 'you are required to'. Action taken: continue to distinguish between comments that are 'recommendations or suggestions' and those that are mandatory requirements.
- (2). Regulatory review comments provided during review of submittals already cites the regulatory authority for any requirement OWASA staff may impose needed to gain approval. In such cases, verbiage in the review comments will identify the OWASA standard and specification, adopted board policy, or State regulatory requirement that mandates such. <u>Action taken:</u> continue to cite and identify regulatory authority for any requirement OWASA staff may impose necessary to gain approval.

Section 29.(c) <u>Informal Review Process:</u>

- (1). There is currently an informal review process in place for reviewing a design sealed by a Professional Engineer when that design or practice is not defined in OWASA standards, specifications, policies or guidelines. Staff employee (Engineering Associate Plan Review) designated to review plans will forward design or process to supervisor (Engineering Manager System Development) who is a licensed Professional Engineer. Engineering Manager will conduct review and render decision. Action taken: None needed.
- (2). There is currently an informal review process in place for a disagreement between the reviewer of the Regulatory Submittal and the Submitting Party regarding whether the statutory or regulatory authority identified by the Regulatory Authority for revisions or requests for

additional information designated as "required" justifies a required change. Staff employee (Engineering Associate – Plan Review) designated to review plans will review with supervisor (Engineering Manager – System Development). OWASA staff (Engineering Associate – Plan Review and Engineering Manager – System Development) will meet with submitting party to review and discuss. Following this meeting, and after consideration of the request and all relevant facts, OWASA will render a decision. <u>Action taken:</u> Engineering Staff have developed an *Informal Internal Review and Appeal* form that will allow for appeal consistent with NCGS 130A-343, Section 29.(c.)).

SECTION 29.(e) <u>Procedure to Develop List of Consulting Professional Engineers.</u> OWASA maintains on staff a licensed Professional Engineer to serve in this role and perform any such review. <u>Action taken:</u> None needed.

Employees at OWASA with regulatory review roles:

- Engineering Manager System Development: Todd Spencer, P.E. licensed professional engineer – supervises, manages and oversees review work performed by Associates
- Engineering Associate Plan Review: Nick Parker performs general plan review
- Engineering Associate Capital Improvement Program: Darren Berger performs general plan review

Action taken: None needed. There are no revisions proposed to any of these working job titles. There is no misidentification or misrepresentation to the public for either of the two Associate positions. These positions titles do not designate nor infer either to be an Engineer but rather an Associate. The Engineering Manager – System Development is currently a licensed professional engineer.
