Part 1A: On-site Water Protection: Standardize Certain Regulatory Review Procedures

Reference Session Law 2014-120, Section 29.(b).

Any system designed or proposed by an engineer including but not limited to those systems specified in 15A NCAC 18A .1938 or .1948 are referred to the State and reviewed according to the steps described in their submitted report. No engineer designed or proposed on-site systems are reviewed by the Wilson County Environmental Health Staff. We verify the application and accompanying information are complete and forward that information to the State for their review. Please refer to the State submitted report.

Part 1B: Food Protection and Facilities: Standardize Certain Regulatory Review Procedures

Franchise and chain food establishment plans are submitted to the State and reviewed and Approved by the Food Protection and Facilities Branch. Local or independent food service facility plans are submitted to and reviewed by a Wilson County Registered Environmental Health Specialist under the conditions as outlined In 15A NCAC 18A .2600 and the NC Food Code Manual. The Wilson County Environmental Health Section reviews swimming pool plans according to the Rules as outlined in 15A NCAC 18A .2500, State issued guide sheets and input from Regional Swimming Pool Protection Personnel to assure all safety requirements and circulation system components are able to meet the water quality requirements. Any engineering questions are referred to the Food Protection and Facilities Branch.
