EXECUTIVE SUMMARY

Pursuant to G.S. 113A-235(c), the Department of Environmental Quality (DEQ) reports to the Environmental Review Commission each year on the implementation of Article 16, the Conservation Easement Program. This Article, §113A-230 through §113A-235, includes enabling legislation for a program for conservation easement promotion/education, quality assurance of conserved lands, and enabling legislation for a conservation grant fund.

Historically the Department operated and reported on the status of the Conservation Easement Program - G.S. 113A-230, Conservation Tax Credit - G.S. 113A-231, and the Conservation Grant Fund – G.S. 113A-232. With the recent re-organization of the Department, the scope of the DEQ Conservation Easement Program has been reduced to the administration of the Conservation Grant Fund and the long-term stewardship of conservation easements and properties held by the Department. Additionally, the Conservation Tax Credit was repealed by Session Law 2013-316. This annual report reflects stewardship activities for Fiscal Year 2016-2017.

ANNUAL PROGRAM UPDATE

The NC Department of Environmental Quality (DEQ) and other state agencies protect natural areas through conservation easement purchases and fee simple land acquisitions. These properties are collectively referred to as conservation lands. Conservation lands are managed in perpetuity by the Department to protect water quality, wildlife habitat and open space. DEQ Stewardship Program activities on these conservation lands include monitoring, enforcement, and site-management activities for the sole purpose of protecting the ecological integrity of these conservation lands. These activities are funded through an agreement with the Division of Mitigation Services (DMS) and with interest generated through the Conservation Grant Endowment.

The Conservation Grant Fund endowment supports monitoring and management of conservation lands acquired thru the Division of Mitigation Services stream, wetland and buffer mitigation programs. Legislation approved in the 2015 session allows for improved financial management of the endowment by diversifying the available investment options. During the 2016-2017 fiscal year DEQ Stewardship worked thru the State Treasurer's Office to diversify the endowment fund investments. These efforts are expected to improve the financial performance of the Conservation Grant Endowment.

FUNDS

The Conservation Grant Endowment (CGE) is comprised of three funds: Principal Fund 6704, Interest Fund 6705, and CREP Interest Transfer Fund 6706 in Budget Code 64307. The operating account for CGE was established as Fund 2410. Per the General Statutes these non-reverting funds were established specifically for stewardship activities (§113A 232). **Table 1** exhibits the balance and expenses for the Conservation Grant Endowment for the fiscal year.

Recent organizational changes in state government resulted in the transfer of Conservation Reserve Enhancement Program (CREP) to the Department of Agriculture (NCDA). During the 2016-2017 fiscal year CREP program funds were transferred to NCDA for long-term funds management. This transfer of funds is reflected in Table 1.

PROPERTIES

During FY 2016-2017 DEQ Stewardship had accepted 33 conservation land transfers from the Division of Mitigation Services. With these additions, DEQ Stewardship is now responsible for the stewardship of 309 conservation lands. An inventory of conservation easements and real properties held by DEQ Stewardship is provided in **Appendix A**.
