Dear Secretary Wos:

Pursuant to Session Law 2013-85, the Secretary of the Department of Health and Human Services (DHHS) shall complete a certification of compliance, in accordance with G.S. 122C-124.2(a), for each local management entity/managed care organization that has been approved by the Department to operate the 1915(b)/(c) Medicaid Waiver and provide a copy of the certification to the Senate Appropriations Committee on Health and Human Services, the House Appropriations Subcommittee on Health and Human Services, the Legislative Oversight Committee on Health and Human Services, and the Fiscal Research Division. Beginning on February 1, 2014, and for all subsequent assessments for certification, the independent review will be made by an External Quality Review Organization approved by the Centers for Medicare and Medicaid Services and in accordance with applicable federal and State laws and regulations.

The Division of Medical Assistance (DMA) contracted with Carolinas Center for Medical Excellence (CCME), who subcontracted with Milliman, to conduct the assessments for fiscal solvency, clean claims payment, and HIPPA compliance. Attached hereto, please find a summary report of the findings for the following local management entities/managed care organizations: Alliance, Cardinal Innovations, CenterPoint, CoastalCare, Eastpointe, East Carolina Behavioral Health (ECBH), MeckLINK, Partners Behavioral Health Management, Sandhills Center, and Smoky Mountain Center.

At this time, based on the attached records, DMA is attesting that all ten organizations are appropriate for certification. There are some financial concerns with MeckLINK and CoastalCare. However, the MeckLink catchment will transition to Cardinal Innovations effective April 1, 2014. CoastalCare has committed to transition to ECBH and Eastpointe at a date that has yet to be determined. DMA and the Division of Mental Health, Developmental Disabilities and Substance Abuse Services (DMH) will continue to monitor both the transition planning and fiscal health of both MeckLINK and Coastal Care. Additionally, the Intradepartmental Monitoring Team (including DMA and DMH staff) determines that all ten LME-MCOs have made adequate provisions against the risk of insolvency based on quarterly financial reports submitted to DHHS.
