NCTracks

NCTracks is the North Carolina Department of Health and Human Services replacement Medicaid Management Information System (MMIS). It is a replacement for a legacy MMIS system that is over 20 years old. It was designed as a multi-payer system, supporting Medicaid, Health Choice, and other programs. The U.S. Government Accountability Office describes MMIS as integrated computer processing operations used by the States to process and pay bills for health care services provided to Medicaid recipients, store and retrieve service and payment data for use in monitoring and analyzing program activity, and generate management reports.¹

In October 1972, federal legislation was enacted that provided for 90-percent Federal financial participation (FFP) for design, development, or installation, and 75-percent FFP for operation of state mechanized claims processing and information retrieval systems approved by the Secretary. For Medicaid purposes, the mechanized claims processing and information retrieval system which states are required to have, unless this requirement is waived by the Secretary of the US Department of Health and Human Services, is the Medicaid Management Information System (MMIS). The Centers for Medicare and Medicaid Services (CMS) define MMIS as an integrated group of procedures and computer processing operations (subsystems) developed at the general design level to meet principal objectives. The objectives of this system and its enhancements include the Title XIX program control and administrative costs; service to recipients, providers and inquiries; operations of claims control and computer capabilities; and management reporting for planning and control.²

Contractual services may be utilized to perform work for the design, development, installation, or enhancement of a mechanized claims processing and information retrieval system. A fiscal agent who is a private contractor to the state, normally selected through a competitive procurement process, may operate the state's MMIS. CSC is the vendor selected to develop and implement NCTracks and is the current fiscal agent for North Carolina.³

NCTracks/MMIS History

North Carolina originally purchased their legacy MMIS from Electronic Data Systems (EDS) in 1977. EDS was awarded a contract to continue operations and enhance the solution in 1988.⁴ Hewlett Packard (HP) acquired EDS in 2008⁵ and continued to operate the legacy system.

Around 2003, the Centers for Medicare and Medicaid Services (CMS) mandated that the State conduct an open procurement for a new MMIS Fiscal Agent contract with newer technology.⁶ To accomplish this, on September 5, 2003, a request for proposal (RFP) for a replacement MMIS was issued by DHHS. Three companies submitted proposals, EDS, ACS, and Unisys Corporation.⁷ On April 8, 2004, the contract for the replacement system was awarded to ACS.⁸ (Note: EDS subsequently protested the award with the Secretary of Health and Human Services and the State Chief Information Officer.⁹)

The ACS MMIS replacement, which was called NCLeads, had a planned completion date of June 2006, which slipped into 2007. On November 21, 2005, the State Chief Information Officer, George Bakolia, classified the project as "red."¹⁰ (The State CIO's Enterprise Project Management Office classifies a project as red when two or more of the "triple constraints"-milestones, cost and scope-are yellow, or one or more is red for more than one month with no approved corrective action in place.¹¹) DHHS submitted a corrective action plan to the State CIO on December 15, 2005. It was rejected on December 30, 2005.¹² In May 2006, State CIO notified DHHS that project would be suspended if issues were not resolved.¹³ The Secretary of DHHS notified the State CIO of her intent to terminate the contract on June 15, 2006,¹⁴ and it was subsequently terminated in July 2006.¹⁵ ACS and the State settled in 2007, after ACS filed a lawsuit. According to a DHHS press release, the Department paid ACS \$10.5 million, \$6.2 million for the work ACS had done and \$4.3 million from savings generated by software resulting from the contract.¹⁶ Total costs for the effort were \$30,575,598.¹⁷

A new RFP was issued, and a new contract was awarded to CSC in December 2008. The second replacement MMIS had an initial go-live date of August 22, 2011. Schedule slippages led to CSC to propose an October 1, 2012 go-live date¹⁸. Scope expansion and schedule slippages led DHHS to propose an operational readiness date to February 28, 2013, and a go-live date of no later than July 1, 2013.¹⁹ With the changes, DHHS reported that the total cost of the contract increased from \$287 million to \$494.8 million. This included:

- An increase in development and operations costs of \$77.2 million
- A two year extension of the contract costing \$75.7 million
- A four-month provider operational preparedness (POP) phase of \$6.4 million
- The addition of HIPAA 5010 and ICD-10 requirements costing \$33.3 million
- Health Information Technology/Medicaid Incentive Payment system (HIT/MIPS) costing \$15.2 million
- A slippage credit from CSC of \$10 million.²⁰

The system went live on July 1, 2013.²¹

NCTracks Costs

The North Carolina NCTracks program includes multiple projects. Costs for the projects associated with the NCTracks program and its predecessor, NCLeads, are included on the spreadsheet below.²² The project budget includes the amount budgeted for design, development, and implementation. Project O&M includes budgeted costs for five years of operations and maintenance. TCO, or total cost of ownership, includes the project costs and the five years of operations and maintenance.
