

Background

SL 2013-360, Section 12E.6 appropriated funds for the Community Focused Eliminating Health Disparities Initiative (CFEHDI) to be used "to provide a maximum of 12 grants-in-aid to close the gap in the health status of African-Americans, Hispanics/Latinos, and American Indians as compared to the health status of white persons." These grants must focus on the "use of measures to eliminate or reduce health disparities among minority populations in this State with respect to heart disease, stroke, diabetes, obesity, asthma, HIV/AIDS, and cancer."

The Department of Health and Human Services (DHHS) must report on these funds appropriated to the CFEHDI. The report must "include specific activities undertaken . . . to address large gaps in health status among North Carolinians who are African-American and other minority populations in this State, and shall also address all of the following:

(1) Which community-based organizations, faith-based organizations, local health departments, hospitals, and CCNC networks received CFEHDI grants-in-aid.

(2) The amount of funding awarded to each grantee.

(3) Which of the minority populations were served by each grantee.

(4) Which community-based organizations, faith-based organizations, local health departments, hospitals, and CCNC networks were involved in fulfilling the goals and activities of each grant-in-aid awarded under this section and what activities were planned and implemented by the grantee to fulfill the community focus of the CFEHDI

(5) How the activities implemented by the grantee fulfilled the goal of reducing health disparities among minority populations, and the specific success in reducing particular

incidences."

CFEHDI is administered by the DHHS, Division of Public Health (DPH), in the Office of Minority Health and Health Disparities (OMHHD).

CFEHDI in SFY 2012-2013

Key accomplishments and activities of CFEHDI in 2013 include the following:

• Partnership development with area Community Care North Carolina (CCNC) networks by the establishment of a medical home for all clients within each of the grantees as applicable. Implementation of the Chronic Disease Self-Management Program for all 12 grantees.

Compliance training provided to all grantees and partners to ensure adherence to policies,

procedures and guidelines.

Grantees received Positive Self-Management Training (PSMP) and Diabetes Self-Management Training (DSMP) to enhance their capacity and skill set to better serve their

population(s).

The following are details outlining the actual activities of the 12 CFEHDI grantees for SFY 2012-2013 that were implemented to fulfill the goals of reducing health disparities among minority populations, specific success in reducing particular incidences, and their respective partners. Appendix A provides a snapshot of the grantees highlighting focus areas, award amounts, populations and regions served.

ACCESSCARE, INC.

Funding - \$208,270

Key Activities Implemented -

Provided the evidence-based Stanford University self-management program called Living Healthy in both Orange and Chatham Counties to focus on the six week series in developing coping skills for patients living with chronic disease

Provided access to medical care for the uninsured as well as Medicaid assistance for those individuals.

• Provided the NC Diabetes Education Recognition Program (DERP) and Medical Nutrition Therapy (MNT) for diabetics in Orange and Chatham counties.

• Developed a curriculum for medical assistants in primary care medical homes that will enable them to support patients with self-management goals.

• Identified that disparities exist due to health-system, care-process, and patient related factors.

AccessCare, Inc. implemented:

- o Patient centered medical homes and quality improvement initiatives at the local hospital system dedicated to address process issues. Engagement of local health department to provide American Diabetes Association (ADA) and Medical Nutrition Therapy (MNT) services.
- o Support from Division of Aging and Adult Services in building on their foundation of lay leaders for the Stanford curriculum.
- O Care management for follow-up in the community, including assistance to the uninsured with access to care, assistance with Medicaid referrals/enrollment, and use of care managers to address patient barriers.

 - O Providing quality interpretation as well as bilingual case management services.
 - O Coordinating and/or providing transportation to appointments for clients who do not have access to transportation.

Key Activities Implemented -

- Provided HIV/STD education, counseling, testing, and referral services for high risk, hard to reach populations.
- Provided free and confidential HIV screenings for young African American men who have sex with men (MSM), in hopes of identifying HIV+ clients (for clients with unknown status) followed by referral to care as indicated.
- Offered self-management classes to assist individuals with diabetes to better manage their condition and decrease their emergency department visits due to complications of their condition.

- Conducted Positive Self-Management Program (PSMP) which instructs on: 1) how to best integrate medication regimens into daily life so they can be taken consistently; 2) techniques to deal with problems such as frustration, fear, fatigue, pain and isolation, 3) appropriate exercise for maintaining and improving strength, flexibility, and endurance; 4) communicating effectively with family, friends, and health professionals; 5) nutrition; 6) evaluating symptoms; 7) advanced directives; and 8) how to evaluate new or alternative treatments.
- Provided outreach to migrant workers to receive healthcare and prevention education on HIV/STDs.
- Referred individuals to HIV/STD testing.
