

Department of Health and Human Services Statewide Standing Order For Naloxone



#### **Authorization of a Statewide Standing Order for Naloxone (1)**

Authorize direct dispensing of naloxone at pharmacies in North Carolina by a state health official issuing a medical standing order for naloxone dispensing.

Under state law a pharmacy can't dispense naloxone without a prescription or a physician's standing order.

- The county EMS Medical Director fills this role for law enforcement and first responders
- A mechanism isn't available for the general public's access to naloxone



#### **Authorization of a Statewide Standing Order for Naloxone (2)**


Authorize direct dispensing of naloxone at pharmacies in North Carolina by a state health official issuing a medical standing order for naloxone dispensing.


- This change will enable pharmacists who recognize the hazard posed by a patients opioid prescriptions to directly dispense naloxone as a safety measure
- Family members will be able to acquire naloxone if they fear a family member is at risk for an overdose
- There is wide support for this action among the Pharmacy, Public Health, Medical and other health professionals who see this as a life-saving step in the face of the opioid epidemic

North Carolina Residents, 1999-2014








### **Prescription Opioid Overdose Deaths Rates + Outpatient Prescriptions Dispensed for Opioids Rate**

North Carolina Residents, 2012-2013



#### 1.9 - 5.25.2 - 7.87.9 - 12.0

<5 deaths; rate suppressed

Average death rate: 5.8 deaths per 100,000 residents

Average dispensing rate: 77,621 prescriptions per 100,000 residents

### Naloxone (1)

#### A life saving antigen to an Opioid overdose

- Naloxone is a medication that reverses the effects of opioid medication.
  - Safe, very effective, and harmless even if administered to someone not experiencing an opioid overdose.
- Naloxone is a first aid tool to combat the current Opioid Epidemic.
  - o Families and friends of an opioid user are trained in the use of naloxone to rescue their loved one in the event of an overdose.
  - Similar to CPR, EPI Pens and AED defibrillators, render first aid and prevent death.
  - Naloxone has proven to be very popular in the 2+ years of use in North Carolina.



### Naloxone (2)


#### A life saving antigen to an Opioid overdose

- By federal regulation, Naloxone is classified as a prescription medication.
  - It's legal to prescribe naloxone, dispensing the drug by medical professionals is subject to rules that vary by jurisdiction.
- In 2013, North Carolina enacted the Good Samaritan/Naloxone Access Law.
  - Cleared the way for law enforcement, fire departments to carry and use.
  - Enabled prescriptions to family members and friends of individuals at risk for overdose.
  - Limited community distribution started under this law.
  - Wide availability is seen as the next step.



#### **Opioid Overdose Reversals with Naloxone (1)**

Reported to NC Harm Reduction Coalition 8/1/2013 to 2/1/2016





## Opioid Overdose Reversals with Naloxone (2)

The Good Samaritan/Naloxone Law in NC is Popular and Effective

- 56 Law Enforcement Agencies across NC now carry naloxone
- 41 have reported using to reverse an overdose
- Wide availability of Naloxone can reduce overdose deaths



### **Impact of North Carolina's 2013**

Good Samaritan/Naloxone Access Law

### Since August 1, 2013

- 23,000 overdose rescue kits distributed
  - 12,366 in 2015 alone
- 2,296 confirmed overdose reversals

### **2015**

1,064 confirmed overdose reversals



### **Impact of North Carolina's 2013**

Good Samaritan/Naloxone Access Law

- North Carolina Reached a Tipping Point in 2015:
- More overdose reversals than overdose deaths
