Adult Protective Services







Mission:

To strengthen, with dignity and respect, the well-being and quality of life for all citizens through supportive services and advocacy.



Catawba County

- Western NC in the foothills of the Blue Ridge Mountains
 - 60 miles NW of Charlotte
 - Largely known as a manufacturing/textile community
 - 405 square miles of both rural and urban areas
- Population of 157,000 citizens
 - Population of residents 60+ = 36,158 (23%)
 - More individuals 60+ than we do ages 0-17
 - Expected that our 60+ population will increase by 32% over the next 20 years
- We must plan for changes in our adult population!





Catawba County - APS

- Adult Protective Services (APS) isn't just for our older citizens
- APS serves any DISABLED adult who has been alleged to be abused, neglected, or exploited and is in need of protective services.
- All 100 County Departments of Social Services are mandated to receive APS reports.
 - The reports are screened to determine if they meet criteria under the APS law and if so, the report is screened in and assigned to a social worker who visits the home and completes an evaluation of the situation.
 - The response time to make the initial visit to the home is based on the seriousness of the report but no longer than 72 hours.





Catawba County - APS

What if the report DOES NOT meet the criteria established under the APS law?

• The report is screened out.

HOWEVER:

In Catawba County we work to provide assistance to individuals in screened out reports by way of INFORMATION & REFERRAL and/or OUTREACH visits by our SW – it's BEST PRACTICE and often BEST for our citizens even though it is NOT required.

• Outreach visit can result in APS services





Catawba County – APS by the Numbers

- From FY 2012 to FY 2017 the number of APS reports increased by 63.5%
 - First 6 months of FY 2017 compared to first 6 months of FY 2018 we've seen another increase in number of reports by 53%
- From July 2017 through December 2017 a total of 105 reports were screened IN and 155 reports were screened OUT.
 - 40/105 screened in reports determined that abuse, neglect or exploitation occurred (38%)
 - 108 out of 155 of the screened out reports were provided I&R and/or an outreach visit by a social worker (70%)





Catawba County – APS by the Numbers

The largest proportion of our APS reports allege SELF-NEGLECT.

- For the first 6 months of the current FY in cases where we determined abuse, neglect, or exploitation had occurred:
 - 55% were SELF-NEGLECT
 - 23% were CARETAKER-NEGLECT
 - 20% were EXPLOITATION
 - 2% were ABUSE





Catawba County – APS by the Numbers

Significant increase in the number *and complexity* of reports all the while seeing a reduction in funding for APS Services (23% reduction)





Catawba County – APS Considerations

The DIFFERENCE between Adult Protective versus Child Protective Services:

- Right to Self-Determination I have the right to allow someone to spend all my money even though I may go without things I need.
- Another consideration: Is there someone who is responsible who is able AND willing to assist the adult?
 - Sometimes we find someone who is responsible and able but NOT willing!

Catawba County – APS Challenges

- Doing MORE with LESS many of our APS clients are in need of services/resources
 - Ex. In FY 12, our APS funding was \$39,396 not even enough to fund ONE position at the minimum salary for a PSSW (\$44,332 w/out benefits)
 - Current funding is \$30,462
- Lack of IN-HOME resources facility placement is COSTLY!
- More complex cases involving younger clients with mental illnesses and/or substance use disorder
- Individuals with a lack of informal supports (family and friends to help)
- Avoiding "Band-Aid" approach to serving
- Serving individuals with "capacity" to care for self but lacking the physical ability or "will" to care for self





Catawba County – APS Successes

Increased participation and involvement at the Law Enforcement and DA level in willingness to prosecute perpetrators.

(When was the last time you saw a headline about elder abuse as opposed to child abuse?)






Catawba County – For Consideration

- APS Laws need to be updated to better fit the population we are now serving
- Envision APS Law that is PROACTIVE rather than REACTIVE
- Include OUTREACH services and increase funding for basic APS services





Catawba County – Possible Solutions

- Pursue grant funding to supplement funding
- Educate the community about APS
- Better marketing as a whole to educate community about vulnerable adult population and needed community support/assistance needs
- Possible program like NC Health Choice for disabled adults who fall in the gap of having too much income for Medicaid but still can't afford other types of insurance
