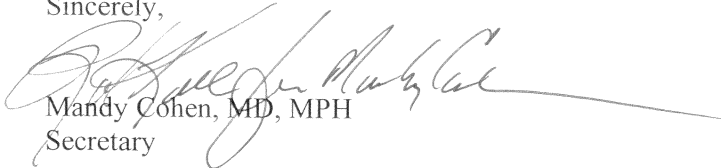

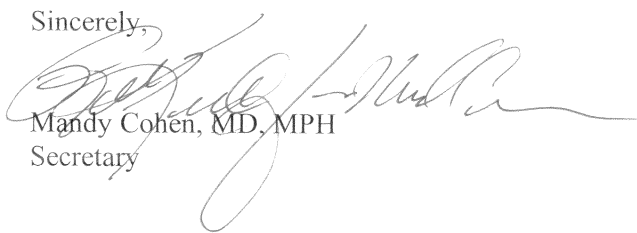

Introduction

North Carolina General Statute 120-208.4.(b) requires the Department of Health and Human Services (DHHS) to submit an annual report on the use of lapsed salary funds by each Division within the Department. For each Division, the report shall include the following information about the preceding State fiscal year:

- (1) The total amount of lapsed salary funds.
- (2) The number of full-time equivalent positions comprising the lapsed salary funds.
- (3) The Fund Code for each full-time equivalent position included in the number reported pursuant to subdivision (2) of this section.
- (4) The purposes for which the Department expended lapsed salary funds.

Lapsed salary is defined as the amount of the budgeted salary and associated benefits for a permanent position that becomes vacant or available during the course of the fiscal year as a result of the employee's separation, reassignment, leave or unpaid leave of absence not expended during the period in which a position is vacant. The majority of employees are located in the Department's 14 state operated healthcare facilities. These facilities provide direct medical care 24 hours per day, 7 days per week. These medical, clinical and highly skilled positions are necessary for these facilities to provide required patient care also represent the hardest positions to fill and retain.

In state fiscal year 2018-2019, DHHS generated \$119M in lapsed salary; of this amount, \$95.6M was repurposed for under-budgeted line items. Of the \$95.6M that was repurposed, \$39M was from state appropriations and \$56.5M was from Departmental receipts. Approximately 70% of the lapsed salary that was repurposed was used for the Division of Mental Health Developmental Disabilities and Substance Abuse Services.

Summary of Primary Usage:

- Costs incurred by permanent and temporary employees and the related fringe benefits.
- Cost related to overtime pay, holiday pay and shift premium differential pay for DHHS permanent staff.
- Workman's compensation costs
- Costs to cover temporary services for critical positions during the period that they are vacant (recruitment and hiring period)
- Legal and administrative costs in support of DHHS programs and operations.
- Mitigate chronic budgetary shortfalls within the Department

This report covers State Fiscal Year (SFY) **2018-2019**, the period **July 1, 2018 through June 30, 2019**. The report is organized into three sections:

- **Summary of Lapsed Salary Availability and Usage** which provides the total amount of lapsed salary for the period required and the number of full-time equivalent positions comprising the lapsed salary funds by Division.
- **Attachment 1** which contains the fund code by division for each full-time equivalent position reported in the Summary; and
- **Attachment 2** which contains the purposes for which the Department expended lapsed salary funds by Division.
