Dear Chairmen:

Session Law 2021-180, Section 9G.11.(b) requires the Department of Health and Human Services, Division of Public Health, to report to the Joint Legislative Oversight Committee on Health and Human Services on funding appropriated to expand local communicable disease programs to address the impacts of the COVID-19 public health emergency. The report shall include the amount of funding pursuant to this section that each county received for surveillance, detection, control, and prevention of communicable diseases, an explanation if the sum of the funding received by all counties under this section is not equivalent to the total funds appropriated each year, information on how the local health departments plan to use and subsequently did use these funds to address surveillance, detection, control, and prevention of communicable diseases. **Funds to Expand Local Communicable Disease

Background

Session Law 2021-180 Section 9G.11.(a) appropriated a non-recurring allocation from the U. S. Treasury's State Fiscal Recovery Fund in the sum of thirty-six million dollars (\$36,000,000) to the Department of Health and Human Services, Division of Public Health for the 2021-2022 fiscal year, to expand local communicable disease programs to address the impacts of the COVID-19. Session Law requires that these funds be allocated to local health departments to expand communicable disease surveillance, detection, control, and prevention activities to address the COVID-19 public health emergency and other communicable disease challenges impacted by the COVID-19 public health emergency.

Distribution of Funds and Methodology

Section 9G.11.(a) directed the Division of Public Health to expend up to eighteen million dollars (\$18,000,000) of these allocated funds during the 2021-2022 fiscal year and any remaining funds during the 2022-2023 fiscal year.

In the distribution of these funds to local health departments under this section, Session Law requires that for each year of the 2021-2023 fiscal biennium, the Division of Public Health shall divide nine million dollars (\$9,000,000) equally among the local health departments based on the number of counties served by each local health department. The Division of Public Health shall distribute the remaining nine million dollars (\$9,000,000) to local health departments based upon the percentage of the State population served by each of the local health departments. The Division shall begin distributing the funds allocated under this section no later than 60 days after this act becomes law. In utilizing these funds, local health departments shall comply with applicable federal rules and guidance governing the State Fiscal Recovery Fund.

Reporting Requirement

SECTION 9G.11.(b) directs the Department of Health and Human Services, Division of Public Health to report no later than February 1, 2022, to the Joint Legislative Oversight Committee on Health and Human Services on the funding appropriated by this section. The report shall include the elements below:

- (1) The amount of funding pursuant to this section that each county received for surveillance, detection, control, and prevention of communicable diseases.
- (2) An explanation if the sum of the funding received by all counties under this section is not equivalent to the total funds appropriated each year.
- (3) Information on how the local health departments plan to use and subsequently did use these funds to address surveillance, detection, control, and prevention of communicable diseases.
- (4) Consistent with the supplement and not supplant intent of this section, the report shall delineate funds other than those distributed in accordance with this section that were received by each county to address surveillance, detection, control, and prevention of communicable diseases.

- (5) Additional information as may be requested by the Joint Legislative Oversight Committee on Health and Human Services. Additional information as may be requested by the Joint Legislative Oversight Committee on Health and Human Services.

This report describes activities undertaken during State Fiscal Year (SFY) 2021-2022. Table 1 details the amount of funding pursuant to this section by county that was received for surveillance, detection, control, and prevention of communicable diseases. The colors within Table 1 correspond with the colors of the relevant districts in Table 2 below. Those colors identify local health departments which serve more than one county. The local health departments will use these funds to address surveillance, detection, control, and prevention of communicable diseases. The Division of Public Health will collect specific information on how the local health departments used these funds for these purposes to fulfill the reporting requirements tied to the U. S. Treasury's State Fiscal Recovery Funds.

The \$18 million allocation for each year of the 2021-2023 fiscal biennium is computed using the statutorily mandated \$90,000 base allocation to each county plus the additional per capita adjustment based upon the percentage of the State population served by each of the local health departments. The per capita allocations below were calculated using the State population figures current as of July 2021. The sum of the funding received by all counties under this section is equivalent to the total funds appropriated each year. Actual allocation amounts will be rounded to the nearest whole dollar.
