

# Bill Draft 2019-MLz-29: ABC Laws Modernization/PED Study.

OVERVIEW: 2019-MLz-29 (i) requires the merger of ABC systems located in a county with two or more ABC systems; (ii) repeals the purchase-transportation permit requirement for spirituous liquor; (iii) requires the ABC Commission to submit a quarterly report on its process for obtaining a contract for State warehouse services; (iv) allows the purchase of individual bottles when placing a special order of spirituous liquor; (v) allows local ABC boards to charge a delivery fee when delivering spirituous liquor to mixed beverages permittees; (vi) allows local governments the option of operating ABC stores on Sundays; and (vii) allows spirituous liquor tastings at ABC stores; as recommended by a Program Evaluation Division report.

BILL ANALYSIS: 2019-MLz-29 does the following:

- <u>Section 1:</u> By June 30, 2021, and to ensure that no county has multiple ABC systems, all ABC systems located in a county with two or more ABC systems shall merge in accordance with the requirements set forth in G.S. 18B-703 ("Merger of local ABC operations").
- <u>Section 2:</u> Repeals the requirement that a person must acquire a purchase-transportation permit to purchase and transport more than eight liters of fortified wine, eight liters of spirituous liquor, or eight liters of the two combined. This repeal would meant that a person could purchase and transport any amount of fortified wine and spirituous liquor without acquiring a purchase-transportation permit.
- <u>Section 3:</u> G.S. 18B-204(a)(3) allows the ABC Commission to contract for the receipt, storage, and distribution of spirituous liquor at and from the State warehouse. The ABC Commission will openly bid for warehouse services before the expiration of the current contract in 2021. This section requires the ABC Commission, beginning October 15, 2019, to submit a quarterly report to the chairs of the Joint Legislative Oversight Committee on Justice and Public Safety detailing the progress made in bidding and selecting an independent contract to provide services under G.S. 18B-204(a)(3).
- <u>Section 4:</u> Rules promulgated by the ABC Commission do not allow a person to place a special order for anything less than a case of spirituous liquor. This section would allow a customer to special order an individual bottle, and allow the ABC store to sell in store any bottles it receives in excess of what was purchased by the requesting customer. Additionally, the ABC Commission is authorized to establish and charge a fee to customers placing a special order.

- <u>Section 5:</u> Allows local ABC boards that deliver spirituous liquor to mixed beverages permittees to charge a delivery fee to the permittee in an amount sufficient to cover the actual costs incurred by the local board in making the delivery.
- <u>Section 6:</u> Allows a city or county to adopt an ordinance allowing ABC stores to be open and selling alcoholic beverages on Sundays.
- <u>Section 7:</u> Upon approval by a local ABC board, this section allows a holder of a spirituous liquor special event permit to give free tastings of its spirituous liquors at an ABC store.

**EFFECTIVE DATE:** Subsections (b) and (c) of Section 1 become effective June 30, 2021. Sections 2 and 4-7 become effective July 1, 2019. The remainder of the act is effective when it becomes law.

# PART I. REQUIRE CONSOLIDATION IN COUNTIES WITH MULTIPLE ABC SYSTEMS

**SECTION 1.(a)** By June 30, 2021, to ensure that no county has multiple ABC systems, all ABC systems located in a county with two or more ABC systems shall merge in accordance with the requirements set forth in G.S. 18B-703. Notwithstanding the provisions of any local act, this section applies to all ABC systems. For purposes of this section, the term "ABC system" is as defined in G.S. 18B-101.

**SECTION 1.(b)** G.S. 18B-700 is amended by adding a new subsection to read:

24 "(c1) Limit on Number of Boards. – Notwithstanding any provision of law to the contrary, there shall be no more than one local ABC board in each county. If a jurisdiction holds an ABC 25 26 store election under G.S. 18B-602(g), the establishment of ABC stores is approved, and the 27 jurisdiction that held the election is located in a county where an ABC board is already in 28 operation, the jurisdiction that held the election shall merge its local ABC board with the existing 29 ABC board in accordance with G.S. 18B-703. Nothing in this subsection shall be construed as prohibiting a local ABC board from serving multiple cities, counties, or cities and counties." 30 **SECTION 1.(c)** G.S. 18B-703(e) reads as rewritten: 31
