#### REPORT TO THE GENERAL ASSEMBLY

Pursuant to S.L. 2014-100, 18B.17. Fourth Quarter 2014 Submitted: January 2, 2015

#### Mission statement.

Legal Aid of North Carolina (LANC) is a statewide, nonprofit law firm that provides free legal services in civil matters to low-income people in all one hundred counties in North Carolina, in order to ensure equal access to justice and to remove legal barriers to economic opportunity.

Funding through the Access to Civil Justice Act (ACJA), G.S. 7A-473.3, constitutes approximately twenty percent (20%) of the total funding LANC receives from all sources to serve the legal needs of the poor in all one hundred counties. LANC is only one of the agencies that receive funding through the ACJA.

#### Whom we serve and how.

LANC serves households with legal issues in housing, public benefits, family integrity, consumer, employment, education, and community economic development. We also serve victims of domestic violence, seniors, and families facing foreclosure whose income qualifications are slightly different. Persons living in poverty not only lack a living wage, but many have health and literacy challenges that severely limit their economic opportunities. In turn, these factors affect the options available to them as they try to resolve legal problems, often without legal representation. LANC does not provide any representation either in criminal matters nor in personal injury cases, nor in class action cases.

LANC serves all one hundred counties of the state. Our primary client base comprises the very poorest: generally households with incomes falling below 125% of the federal poverty guidelines (FPG); slightly more than \$29,000 per year for a household of four. Our general client base comes from the roughly 3.7 million people, approximately 39% of the state's general population, falling at or below 200% of the FPG.

The poverty population in North Carolina has increased in the last ten years. The latest census statistics indicate that the state's poverty rate is 17.9% and North Carolina now has over 1.71 million people living at or below the FPG. Over 2.23 million of the state's population lives on incomes at or below 125% of the FPG. These figures include over 15.5% of all seniors, 32.1% of all children; 24.9% of all women. About 7.9% are considered in extreme poverty and have incomes below 50% of the FPG. Over 19.6% of households are food insecure. Over 606,000 households pay more than 30% of income on housing and just over 12,000 people are homeless; yet only 136,700 households receive federal rental assistance. Contrary to conventional wisdom, only 40,905 of these many poor households in our state receive TANF, which traditionally is "welfare." The majority of the households living in poverty are headed by females. The median gross annual income of LANC clients remains approximately \$12,000, significantly less than the living wage annual income of \$41,920 for a four-person household and the \$45,906 state median income. Poverty is not constrained by geography, and the poor live in both urban and rural areas.

North Carolina is about 66.1% urban and 33.9% rural. The major urban areas have experienced a 60% increase in population since 2000.

Our legal work focuses on the most basic needs of the poorest households in the state.

LANC makes every effort to provide the highest quality legal advice and representation to our clients. As a civil legal services provider, we make every effort to ensure that our work ameliorates poverty and creates economic opportunity for those most in need. We prevent and reduce homelessness, we reduce food insecurity for children, we help enforce consumer protection laws on behalf of seniors and veterans, we help women and children escape domestic violence.

Through our 150 staff attorneys, along with 40 paralegals and 60 support staff, each year we provide direct legal assistance to approximately 25,000 households and legal education and outreach clinics information to an additional 25,000 households. LANC focuses its legal practice on critical basic needs: housing, consumer, public benefits, family, education, employment, health care, and elder law. LANC also employs statewide, special provider units that address specific issues: Advocates for Children's Services specializes in education issues and combating the School To Prison Pipeline. The Domestic Violence Prevention Initiative and Battered Immigrant Project focus on protecting victims of abuse and reducing the incidence of domestic violence. The Child's Advocate protects children and resolves complex, high-conflict custody matters. The Mortgage Foreclosure Project saves homes and home equity and protects homeowners from abusive lending and loan servicing practices—the project is a multi-partner project with a thousand open cases on any given day. The Senior Law Project and its toll-free hotline focus on the needs of the 240,000 seniors in poverty in our state. The Fair Housing Project works across the state to educate renters, owners, and landlords in order to fight housing discrimination in all its forms.

LANC settles about 65% of its cases without litigation. When it goes to court however, it prevails over 90% of the time. When litigation is the best legal strategy for the client, LANC has a highly trained and experienced staff that is prepared to go to court to fight for its clients rights. LANC zealously litigates cases in every forum and at every level in the state and federal courts, including jury trials and through appeal in all jurisdictions. LANC's legal advocacy also includes community education and outreach, consultations, and negotiation before litigation. We employ an informative website that permits clients to gain knowledge about legal issues and to contact any office in the state for direct help or for local *pro se* information. We also employ social media tools such as Facebook, Twitter, and e-newsletters. Much of our Helpline, our call center, work involves specific legal advice to address important legal issues or some brief service before litigation is pursued. The Helpline is set up and staffed to help thousands of clients each year. Each year, LANC recruits lawyers from corporate firms and the private bar to provide *pro bono* representation to our clients. These lawyers donate hundreds of hours to provide access to justice for our fellow citizens.

#### Activity in 2014.

In 2014, LANC began a intensive expansion of its work with veterans. We trained and certified approximately 30 advocates on veterans law. We participate in veterans "Standown" outreach

events all over the state. LANC is part of the Veterans Pro Bono Network, which includes the North Carolina Bar Association and the state's law schools. We focus not only on veterans' benefits, but w strive to serve comprehensive legal needs, including issues affecting veterans' abilities to obtain employment and decent housing. In the past year, LANC directly served over 1,600 veterans as clients and over 2,700 households in which a veteran was a member. The second project is what we call "Re-entry." Re-entry advocacy helps clients clean-up arrest, conviction, and discharge records so that they again can qualify for employment and decent housing. Removing barriers to employment helps reduce the rate of recidivism for those, mostly, young men who have earned an opportunity for a second chance. The third project of note is called "Lawyer on the Line (LOL)." The LANC Helpline, the name of our toll-free call center that receives 2000 calls per month. The Helpline provides first-rate legal advice or brief service in situations where the client needs actual legal assistance but may not need to go to court right away. Lawyer on the Line is the project that recruits lawyers from the private bar to provide free consultations on poverty law issues to eligible clients. The average LOL case requires about two and one-half hours. LOL has recruited nearly one thousand lawyers and served over 3,000 clients.

Other noteworthy projects: Our Mortgage Foreclosure Project continues to save homes and the credit of thousands of families. Our collaborative, multi-agency project to become the most vigorous foreclosure defense projects in the country. We continue to shape and to expand our Medical-Legal Partnership Project. MLPs place lawyers in public health clinics to give medical staff the resources they need to change the social determinants of health. MLPs can reduce unnecessary returns to clinics and ERs, reduce community healthcare costs, and actually improve community health. The initial efforts in Durham have enabled LANC to obtain funding for similar projects at UNC, in Winston-Salem, Charlotte, Greensboro, and Moore County, which received a grant to help reduce unnecessary--and costly--return trips to the emergency room..

Access to Justice: Veterans and Second Chance Projects Fourth Quarter 2014.

#### **VETERANS PROJECT OVERVIEW**

#### **DURHAM VAMC CLINIC**

Leading up to the Fall/Winter 2014 monthly onsite legal clinics at the Durham VA Medical Center, Legal Aid conducted a training at the Durham County courthouse in September for pro bono law students from the three participating law schools (UNC-CH, Duke and NCCU). Notably, legal services are cited as 4 of the top 10 unmet needs -- of all types, not just legal -- by homeless veterans, VA staff and community providers based upon the most recent published VA report (See attached Project CHALENG Fact Sheet, May 2014). These survey results have been instrumental in guiding the direction of some of our current efforts. Legal Aid's focus for veterans who attend the mobile legal clinics on VA property are reentry/second chance based with referrals coming from the distinguished VA social work staff. The two specific areas covered at the substantive legal training: (1) expunctions/Certificates of Relief/occupational licenses, and (2) incorrect child support orders for now disabled veterans who are at risk of incarceration for contempt of court for failure to pay or have previously been incarcerated for

contempt of court. This training program provided critical information about best practices when working for persons with disabilities.

Later in September, pro bono law students from NCCU School of Law volunteered their Friday to interview clients at the Durham VAMC. They then came to our field office the following Friday to conduct further investigations and follow-up with those clients. One of these veterans is our first occupational license client. He is a skilled nurse who is currently completing the TROSA residential program. On this same follow-up date, the law students, under the direction of one of our NCVetCorps members, Mr. Shelley Bennett, contacted 65 veterans who requested additional follow-up from the 2014 Bull City Stand Down to provide more information about our legal services. Ultimately, Mr. Bennett met in-person with 25 of these individuals, including some during this quarter.

In October and November, LANC attorneys, NCVetsCorps members along with UNC-CH and Duke students, respectively, continued the Durham VAMC Clinic model that began in September. From these intakes, the students would later provide brief service for a veteran with an incorrect child support order, as well as assist with multiple expunction eligibility determinations.

#### MOBILE EXPUNCTION CLINICS

The Second Chance Employment and Housing Project partnered with the LANC-Raleigh Office to host an expunction clinic at the Wake County Veterans Stand Down on October 16, 2014. Service providers participating in the Stand Down were trained on expunction eligibility and asked to refer individuals within their service populations who were likely eligible for relief. Referrals of veterans were prioritized. There were a total of 59 successful referrals, including 5 veterans. Of these 59 clients, 28 individuals were determined to be eligible for expunction, of which 23 are now being provided extended service by the LANC-Raleigh Office. Thirty-one (31) clients were determined ineligible for expunction and these individuals were advised of their ineligibility and provided copies of their criminal records.

In October, in partnership with Elon University School of Law's Pro Bono Board, LANC attorneys supervised students for an expunction clinic that saw 23 intakes in-person where 13 (4 veterans) were ultimately eligible for relief and 7 petitions were completed by students on the spot. For Elon's part, the planning was done almost entirely by one hardworking student, as they had no pro bono faculty employed for the majority of the preparation time. The addition of a mobile clinic with Elon means that all seven law schools in North Carolina have collaborated with Legal Aid to provide second chance legal assistance to persons currently living in low income households.

#### STAND DOWNS ACROSS THE STATE

Legal Aid had a presence at 13 Stand Downs across the State in 2014, at last count, with 6 of those occurring in the 4<sup>th</sup> quarter.

At the 2014 Bull City Stand Down in Durham, law students from Duke met with a LANC attorney and clients to begin work on what would become a multi-client statewide partnership between the two organizations in investigating and helping veterans pursue disability claims with

the VA from start to finish. Six (6) clients from this quarter are currently part of this unique project.

#### **CLIENT SUCCESS STORIES**

In October 2014, the very first NCVetsCorps client, who had been previously assisted with gaining eligibility for VA benefits, was granted an expunction. This resulted in a criminal record that was clear of all charges and convictions dating back 20+ years and improved confidence when interviewing for employment.

In October 2014, a client was referred by a non-LANC NCVetsCorps member at a local homeless shelter because his HUD VASH voucher had been prematurely terminated and the grievance hearing was to take place in 3 days. Within 24 hours of intake, the voucher was reinstated based on the discovery of several serious errors in due process. Using the average 60 month subsidy award amount calculation, the client's voucher is a savings worth \$35,340 over that period.

In November 2014, an expunction was ordered for a veteran who we became engaged with at the very first mobile legal clinic conducted at the Durham VAMC in May 2014. When I shared the good news with him a couple of weeks ago, he volunteered the following remarks: his faith in the justice system was restored, he holds a high opinion of Legal Aid for engaging in this type of work, and he greatly appreciated having the close working connection to our NCVetsCorps member (also a veteran) who remained his contact person until the court issued its order.

#### SECOND CHANCE PROJECT OVERVIEW

Our Second Chance Employment & Housing Project was established in order to more fully address barriers to gainful employment and affordable housing confronting low-income individuals with criminal records. With a staff of five attorneys, including three AmeriCorps/Equal Justice Works Fellows who joined the group on September 22, 2014, the project provides support to staff and volunteer attorneys providing reentry-related legal services; staffs mobile expunction clinics across North Carolina; coordinates direct-referral partnerships targeting low-income individuals likely eligible for relief; and hosts community information sessions and professional trainings. As reflected by the figures and activities detailed below, the Second Chance Employment and Housing Project, in concert with the local field offices and other special projects, have served more than 550clients this quarter while significantly growing LANC's capacity to provide high-quality, second chance-focused legal services.

#### Statewide Intake Support

The Second Chance Employment and Housing Project integration within LANC's statewide intake system has significantly increased the capacity of LANC to provide high-quality, reentry-focused legal services across North Carolina. In collaboration with Legal Aid's Central Intake Unit (the "HelpLine"), the Second Chance Employment and Housing Project procures statewide background records for all clients completing intake through the HelpLine and identifying reentry-related legal services as a need. Based upon a review of these criminal records, preliminary determinations of eligibility for expunctions and Certificates of Relief are attached to

clients' files. Providing these statewide criminal records, as well as pre-determinations of eligibility, ensures LANC staff and volunteer attorneys have immediate access to the information necessary to make accurate determinations of eligibility and are able to reference expert legal interpretations as needed to ensure the high-quality delivery of legal services. Between October and December 2014, the project provided criminal records and predeterminations of eligibility for more than 326 clients completing general intake through the HelpLine and seeking reentry-related relief. Project staff remains available to provide assistance to volunteer and staff attorneys throughout these clients' representation.

#### Mobile Reentry Clinics

The Second Chance Employment and Housing Project coordinates and staffs mobile reentry clinics throughout North Carolina. In addition to the delivery of legal services, these clinics typically include training for volunteer attorneys and law students, a continuing legal education class for members of the local bar, and a "Tools of Relief" workshop for directly-impacted individuals. Between October and December 2014, the project staffed mobile reentry clinics in Guilford County, Wake County, and New Hanover County. Additionally, the project provided technical support for a mobile reentry clinic in Burke County. Approximately 225 individuals were provided legal services at these clinics. Highlighted below are figures from the New Hanover mobile expunction clinic hosted on October 15-16, 2014.

In partnership with New Hanover County District Attorney's Office and the UNC School of Law Pro Bono Program, the Second Chance Employment and Housing Project hosted an expunction clinic in Wilmington, N.C., on October 15-16.

<u>Partners</u>: New Hanover County District Attorney, New Hanover County Manager's Office, United Way of the Cape Fear Region, UNC School of Law, Chief Justice's Commission on Professionalism, New Hanover County Bar Association, Legal Aid HelpLine

Student Involvement: 27 UNC law students interviewed clients and assisted in preparation of petitions for expunctions and certificates of relief.

<u>Clients</u>: 110 clients attended the clinic (of 129 screened as LSC-eligible prior to the clinic).

<u>Services</u>: 64 clients were determined eligible for expunctions or certificates of relief and are being represented by project staff.46 individuals were determined ineligible for relief. These individuals were provided a copy of their statewide criminal record and informed of their ineligibility.

<u>Training</u>: law student volunteers completed a three hour substantive legal training; 40+ local attorneys completed a three hour CLE on collateral consequences of criminal records and tools of relief earlier in the year; approximately 300 individuals attended a community education workshop in June from which an interest list was generated for participation in the October clinic.

#### Direct-referral Partnerships:

One in five North Carolinians—or approximately 1.6 million individuals—have a criminal record. Coupled with the limited nature of expunction eligibility, this staggering number of individuals makes it essential to target Legal Aid's services to low-income individuals most likely eligible for relief. In order to reach more individuals who are likely eligible for legal relief and whose employment and housing prospects would thereby be improved, the Second Chance

Employment and Housing Project has established and is coordinating direct-referral partnerships between agencies best positioned to identify such individuals. Listed below are the agencies as well as the referral criteria specific to each agency.

Public Defender Offices (Mecklenburg, Chatham, Pitt)

-Individuals whose felony charges are dismissed or disposed not guilty

District Attorney Offices (New Hanover)

- -Individuals whose felony charges are dismissed or disposed not guilty
- -Individuals who convictions are the result of being victims of human trafficking

Department of Commerce, Offender Specialists (Statewide)

- -Individuals with dismissed charges and no felony conviction
- -Individuals with convictions occurring before the age of 18
- -Individuals with first-time convictions

#### DisabilityRightsNC

- -Individuals with dismissed charges and no felony conviction
- -Individuals with convictions occurring before the age of 18
- -Individuals with first-time convictions

#### Durham VA Medical Center, Social Workers

- -Individuals with dismissed charges and no felony conviction
- -Individuals with convictions occurring before the age of 18
- -Individuals with first-time convictions

#### Domestic Violence Agencies/Sexual Assault Advocates

- -Individuals with dismissed charges arising from domestic violence
- -Individuals denied occupational licensing based on charges arising from domestic violence

These direct-referral partnerships are supported through a pilot LSC-eligibility screening program with students enrolled in the North Carolina Central School of Law's night program. The students complete the first phase of the online application for individuals referred through the various direct-referral partnerships. Screening is then completed by HelpLine staff.

Community Education Sessions, Substantive Legal Trainings, and Other Pro Bono Activities
Between October and December 2014, the Second Chance Employment and Housing Project
hosted community education sessions on the collateral consequences of criminal records and
potential tools of relief with the following direct-service organizations: Dress for Success
(Raleigh, Durham), Durham Public Housing Authority, Freedom House (Roxboro), Domestic
Violence/Sexual Assault Prevention Advocates and Shelter Staff (Mecklenburg County);
veterans services providers (Wake County); Mecklenburg County Sheriff's Office (annual
community forum, "Changing Lives, Changing Futures- Jobs Not Jail"). In the same period, the
project conducted substantive legal trainings for the following groups: UNC School of Law pro
bono students; Elon School of Law pro bono students; Alamance County Bar Association; and
LANC-Fayetteville Office.

In late October 2014, NCVetCorps member Shelley Bennett referral a veteran to the North Carolina Department of Commerce-Veteran Division for assistance with employment

opportunities as well as to a VA social worker for assistance in gaining admittance into the VA Hud Vash program. In mid-November, the veteran came to the Durham field office to report that he was ecstatic about receiving "his very own place" after so many years of denials based on his criminal involvement. He had a regained sense of independence because of acquiring stable housing. This veteran was more than grateful for our role in connecting him to the right providers. [This client success story highlights the reverse referral relationships we have developed with both the Commerce Department and the VA social work staff].
