Re: Western Youth Institution Asset Report

Date: March 1, 2018

Pursuant to Session Law 2017-57,16C.6 the Department of Public Safety (DPS) shall make every effort to ensure that equipment and other State resources in buildings that are scheduled for demolition or otherwise not being used are recovered for use elsewhere. DPS shall report by March 1, 2018, on assets salvaged, the estimated value of the asset, where it was used, and the savings associated with relocating the asset to another facility.

Per legislative directive, Western Youth Institution was closed December 31, 2013. Fixed assets and non-fixed assets were inventoried as required and assessed for relocation to another facility, recognizing some assets are no longer functional. Fixed assets were defined in 2013 by NC Department of Public Safety Policies and Procedures 1C Fiscal Administration .2703 Fixed Assets Defined as "...an accounting term used to describe property, plant and equipment that is tangible in nature, assigned to a particular location and used in the normal operation of the Facility/Section. Fixed assets can include land, buildings, equipment, furniture, machinery and other like items."



Appendix 1 lists the fixed assets that were transferred following the closure date of December 31, 2013. The fixed asset number, item description, acquisition costs, cost of replacement, the facility that received the asset and the date of acquisition are provided. The estimated total values of fixed assets were \$3,068,305.57.
