

**COUNTY OF AVERY  
LIST OF ORDINANCES PER  
SESSION LAW 2018-69**

**Mountain Ridge Protection Ordinance** – Regulates the height of tall buildings on Mountain Ridges.

**Soil Erosion and Sedimentation Control Ordinance** – Regulates certain land disturbing activity to control accelerated erosion and sedimentation in order to prevent the pollution of water and other damage to lakes, water courses, and other public and private properties.

**Limit Height of Objects around Avery County Airport Ordinance** – Regulates and restricts the height of structures and objects of natural growth and regulates the use of property in the vicinity of the Avery County Airport by creating the appropriate zones and establishing the boundaries.

**Watershed Protection Ordinance** – Regulates, prohibits, or abates acts or omissions concerning the health, safety or welfare of the citizens of Avery County. The provisions of this ordinance shall apply only to such areas in Avery County as have been lawfully designated as water supply watersheds.

**Misuse of “911” Emergency Telephone Number System Ordinance** – Regulates misuse of the “911” Telephone System.

**Residential Numbering and Lettering Ordinance** – Implements a systematic number and lettering system for all residences within the geographic limits of Avery County.

**Road Naming Ordinance** – Provides a uniform system of road naming along both public and private streets and roadways in order to facilitate provision of adequate public safety and emergency response services.

**Maximum Building Height Ordinance**--Regulates the construction of tall buildings or structures as herein defined in all areas of the unincorporated county which are not otherwise regulated by the Mountain Ridge Protection Ordinance of Avery County.

**Sexually Oriented Businesses Ordinance** – Regulates sexually oriented businesses in order to promote the health, safety, morals and general welfare of the citizens of Avery County and to establish reasonable and uniform regulations to prevent the deleterious location and concentration of sexually oriented businesses within the city.

**Parades, Demonstrations and Street Events Ordinance** – Provides a permitting system for conducting parades, picketing, and other street events.

**Alcoholic Beverages Ordinance** – Unlawful for any person to consume any intoxicating liquor on any property owned or controlled by the county or public vehicle or pedestrian area.

**Solid Waste Ordinance** – Regulates storage, collection, and disposal of solid waste.

**High Impact Ordinance** – Establishes certain criteria relating to High Impact Industries.

**Subdivision Ordinance** – Establishes standards and procedures for the subdivision and re-subdivision of land within the territorial jurisdiction and to provide for the orderly growth and development of the county.

**Smoking Ordinance** – Regulates smoking in or on county property. Protects and promotes the public health and safety of the citizens of the County by controlling and limiting the smoking of tobacco in public places and places of employment.
