This listing excludes provisions imposing only civil fines and provisions imposing civil fines that may be imposed in addition to criminal penalties. (See the bottom of the final page for notes concerning the county's general penalty.)

¹ Sections 6-8 through 6-15 listed above are designated as Class 3 misdemeanors (in section 6-2) which, under G.S. 14-4, are subject to a maximum fine of \$50 (unless the county specifies a higher fine—up to a maximum of \$500, which in this instance it does not). Section 6-7, however, states that violation of it constitutes a Class 1 offense. Assuming "offense" means misdemeanor, the maximum fine is \$1,000 which is beyond the authority given in G.S. 14-4. I have assumed for purposes of this listing that the county intended that all these animal related violations be subject to the same penalty. NOTE: Class 1 penalties (2) included in the UDC have been omitted as not derived from G.S. 14-4.

² Section 6-2 provides that the penalty for violations of article II, which includes the rabies related provisions listed, shall be "those penalties otherwise set out in state law." G.S. § 130A-25 provides that violations of chapter 130A are misdemeanors. The penalties shown assume that the reference to state law penalties is a reference to the criminal penalties of G.S. 14-4 as shown.
