Macon County Soil and Sedimentation Control Ordinance

Any person who knowingly or willfully violates any provision of this act, chapter, or rule or order adopted or issued pursuant to the Act or this chapter or who knowingly or willfully initiates or continues a land disturbing activity for which an erosion control plan and or land distrubing permit is required except in accordance with the terms, conditions and provisions of an approved plan and/or land disturbing permit shall be guilty of a class 2 misdemeanor

Macon County Solid Waste Ordinance

Violations of this chapter shall constitute a misdemeanor punishable by a fine not to exceed \$500 or imprisonment for not more than 30 days or both. Each act shall constitute a separate violation

Macon County Subdivision Ordinance

Any person who, being the owner or agent of the owner of any land located within the jurisdiction of this ordinance, thereafter subdivides his land in violation of this ordinance or transfers or sells land by reference to, exhibition of, or anyother use of a plat showing a subidivison of land before the plat has been properly approved under the terms of this ordinance and recorded in the office of the macon county register of deeds shall be guilty of a misdemeanor.
