## Report Submitted by New Hanover County as Required by Session Law 2018-69

#### Chapter 1 – Section 1-6 (b) - Enforcement of Ordinances

Violation of any provision of the chapters and/or sections of the code shall be a misdemeanor and punishable as provided by NCGS 14-4.

#### Chapter 2 - Administration

Section 2-186 - Prohibits officials of county from voting or acting on items where there is a conflict of interest.

#### Chapter 5 – Animals

Section 5-1 - Provides criminal enforcement related to requirements of registration and vaccinations, public nuisance issues, dangerous dog issues, kennel permits.

### <u>Chapter 8 – Wilmington International Airport Rules and Regulations</u>

Section 8-1 Failure to comply with or willful violation of rules and regulations of the airport may be enforced with misdemeanor warrant.

#### Chapter 14 –Businesses

Section 14-103 prohibits false statement in obtaining privilege license and\conducting business without obtaining or paying for privilege license

Section 14-171-criminal enforcement of regulations on pawnshops

#### Chapter 17 – Civil Emergencies

Section 17-71- violations of a variety of state of emergency restrictions such as curfew, alcoholic beverages, weapons, access

Section 17-231-violations of price gouging restrictions

#### Chapter 20 – Emergency Services

Section 20-61 – prohibits obtaining or receiving ambulance service without intending to pay for service and any violation of the terms of an ambulance service franchise

Section 20-101 -violation of regulations related to private alarms systems

#### Chapter 23 – Environment

Section 23-31 - prohibits noise in excess of specific decibel levels and other types of noise in specific situations

Section 23-81 - violation to obstruct county officials engaged in abatement of public nuisance Section 23-251 – prohibits regulated land disturbing activity except in accordance with erosion control plan

### <u>Chapter 26 – Fire Protection & Prevention</u>

Section 26-1 unlawful to burn during declared hazardous conditions

Section 26-31 unlawful to violate state fire prevention code

#### Chapter 29 - Floods

Section 29-41 unlawful to violate or fail to comply with flood plain management regulations, conditions and safeguards established for development within special flood hazard areas

#### Chapter 32 – Health & Sanitation

Section 32-51 -prohibits smoking in certain public places and establishments and on county property

## Chapter 38 - Offenses & Misc. Provisions

Section 38-31 – prohibition to carry firearms on county property

Section 38-32 – prohibits graffiti without consent

Section 38-33 – prohibits alcohol in county buildings

Section 38-61 – prohibits public display of sexually explicit material

Section 38-101 - prohibits breaches of peace such as public urination, rioting, drug-related

loitering, begging on county property

Section 38-105 - prohibits sale, discharge of fireworks

Section 38-106 – prohibits discharge of firearms in a reckless manner

Section 38-108 – prohibits harassment of birds

Section 38-110 – prohibits providing contraband to prisoners

Section 38-111 - prohibits begging in aggressive manner

## Chapter 41 - Parks

prohibits violation of rules and regulations in county parks

#### Chapter 44 – Solid Waste

Section 44-5 – prohibits violation of provisions of this chapter primarily regarding the disposal of waste

Section 44 -58 – prohibits violation of some provisions of solid waste franchise agreements

Section 44-88 – prohibits violation of regulations regarding yard waste and other banned materials

#### Chapter 53- Traffic

Section 53-1 – prohibits violation of rules and regulations regarding parking on county property Section 53-31 – prohibits operation of vehicles in dune areas

#### Chapter 59 – Waterways

Section 59-33 – prohibits failure to comply with regulations regarding sand dune protection Section 59-118 – prohibits violation of rules and regulations regarding personal watercraft safety
