

**PERQUIMANS COUNTY, NORTH CAROLINA**  
**LIST OF APPLICABLE ORDINANCES**  
**PUNISHABLE AS A MISDEMEANOR**  
**PURSUANT TO N.C. SESSION LAW 2018-69**  
**(H.B. 379)**

**Ordinance 3-State of Emergency Ordinance:** Any person violating any prohibition or proclamation authorized by the ordinance shall be guilty of a misdemeanor.

**Ordinance 7-Soliciting Ordinance:** It shall be a misdemeanor to engage in door to door sales without invitation or to engage in other similar sales or solicitations without a permit.

**Ordinance 12-Snug Harbor Shooting and Firearm Ordinance:** No person shall fire or shoot any firearm within the Snug Harbor Subdivision and a violation of this ordinance shall be punishable as a misdemeanor.

**Ordinance 13-Animal Control Ordinance:** It shall be a misdemeanor for any person to keep a dog which is dangerous, potentially dangerous or vicious without registering such dog and without receiving a permit for the keeping of such dog.

**Ordinance 28-Addressing Ordinance:** Violation of this ordinance shall be a misdemeanor if persons do not number their residence in accordance with the provisions of the ordinance.

**Ordinance 29-Albemarle Plantation Shooting and Firearm Ordinance:** No person shall fire or shoot any firearm within the Albemarle Plantation Subdivision and a violation of this ordinance shall be punishable as a misdemeanor.

**Ordinance 42-Water Shortage Response Ordinance:** Persons in violation of the ordinance may be charged with a misdemeanor for using water in violation of the ordinance.

**Ordinance 50: Solid Waste Ordinance:** Ordinance makes it a misdemeanor for any owner, occupant, tenant or lessee to deposit, store or permit to accumulate any solid waste on his property that is not stored or disposed of in a manner prescribed by the ordinance.

**Ordinance 52-Junkyard Ordinance:** Any person, firm, corporation or other entity who maintains or operates or who controls the maintenance and/or operation of a junkyard or automobile graveyard in violation of the ordinance shall be guilty of a misdemeanor.

**Ordinance 59-Skateboard Park Ordinance:** The ordinance requires all users of a skateboard park to wear a helmet, elbow pads and knee pads and a violation of the ordinance shall be punishable as a misdemeanor.

**Ordinance 83-Holiday Island Shooting and Firearm Ordinance:** No person shall fire or shoot any firearm within the Holiday Island Subdivision and a violation of this ordinance shall be punishable as a misdemeanor.

**Ordinance 95-Noise Ordinance:** It shall be unlawful to create or assist in creating any unreasonably loud, disturbing and unnecessary noise and any violation of the ordinance shall be a misdemeanor.

**Ordinance 99-Flood Damage Prevention Ordinance:** Violations of any provisions of the ordinance may be punishable as a misdemeanor.
