

PERSON COUNTY GOVERNMENT

Report on Ordinances with Criminal Sanctions

Ordinance and Conduct subject to criminal punishment

1- Auto Graveyards & Junk Yards

Operation of unlicensed auto graveyard or improper screening

2-Animal Services

Interfering with animal services officer or a veterinarian performing duties under the ordinance; failure to have animals vaccinated against rabies; failure to properly care, feed or shelter domesticated animals; treat animals cruelly (defined extensively in the ordinance); Failing to notify proper authority when a person has injured a domestic animal by vehicular means; allowing your domesticated animal to threaten or injure others or to be a public nuisance; allowing a female animal to run at large during estrous; allowing a dog to bark and otherwise annoy for a projected period neighbors; allow a dangerous dog to be unattended or to run at large; Keep a dog or cat not owned by the person in possession; failure to have cat, dog or ferret wear a collar or other suitable harness to display rabies tag

3- Abandoned structure ordinance

Prohibits failure to comply with an order regarding repair, closure, vacation or abatement of an abandoned structure which is subject to the ordinance.

4-Emergency management ordinance

Prohibits interference, obstruction, hindering or delaying any EMS personnel in performance of their duties or to violate any emergency plan.

5- State of Emergency ordinance

Prohibits non-compliance with valid rules under a state of emergency order issued by the county.

6- Road naming and addressing

Prohibits without County approval naming roads, erecting a street sign, removing or defacing a street sign, or assigning a number

7-Banning smoking in county recreational facilities and grounds

Prohibits smoking in county recreational facilities and buildings and in county buildings and facilities which are prohibited by person county health department regulations

8-Consumption of wine or beer on county property

Prohibits consumption of wine or beer on county property except where specifically permitted (generally recreational facilities)

9- Fishing and Diving from Bridges

Prohibits fishing or diving from bridges in the County.

10- Noise Ordinance

Prohibits defined noise at specified times of day.

11- Requiring unregistered motor vehicles to be screened from public view

Requires 3 or more unregistered vehicles to be screened from public view.

12-Prohibiting take-off or landing of aircraft on Hyco Lake

Prohibits aircraft from take-off or landing on Hyco Lake in Person County.

13-Subdivision Ordinance

Selling property by reference to a plat prior to recordation

14-Planning Ordinance

Any violation of any provision

15- Storm water ordinance

Any violation of the ordinance

16-Sexually oriented business

Violation of any provision

17-State of Emergency declaration

Violation of any rules promulgated

18-Junk yard regulation

Violation of any provision by a commercial junk yard

19- Open and concealed carry of weapon

Prohibits open or concealed carry of a weapon in or around County Human Resources Office.
