***RE: Town of Bethania -- List of Ordinances per Session Law 2018-69***

Greetings:

As Town Attorney for the Town of Bethania, I submit to you the following list of ordinances of the Town of Bethania which, to the best of my knowledge, could be punishable pursuant to G.S. 14-4(a):


- **Ordinance 1:** An Ordinance and Resolution Providing that All Ordinances and Actions Having the Effect of Ordinances of Forsyth County Shall Be Applicable Within the Town and Jurisdictional Limits of the Town of Bethania (prohibiting all conduct prohibited by Forsyth County).
- **Ordinance 5:** An Ordinance Designating All Areas Within the Corporate Limits of the Town of Bethania as a Bird Sanctuary (prohibiting the hunting, killing, trapping or taking of any domestic or wild bird within the Town limits).

- **Ordinance 6:** An Ordinance Permitting the Posting of Signs Prohibiting the Carrying of Concealed Weapons on Certain Municipal Property (authorizing signage to prohibit concealed weapons on Town property).<sup>1</sup>
- **Ordinance 7:** An Ordinance Prohibiting the Display of Firearms Within Local Government Buildings, Their Appurtenant Premises, and Parks (prohibiting the display of firearms within Town buildings, appurtenant premises and parks).
