Ordinances That Create Criminal Penalties pursuant to NCGS §14-4(a)

NOTE 1: The first number of the ordinance sections listed below denotes the chapter in the Code of Ordinances for the Town of Black Mountain (the "Code"). Appendix A of the Code of Ordinances, the Land Use Code ("LUC"), has its own chapter numbers, but none of those are included here as §1.1.10 of the Land Use Code provides that civil penalties may be imposed for any violation of the Land Use Code.

NOTE 2: The various ordinance sections set out below may impose criminal penalties pursuant to N.C.G.S. §14-4(a) in three ways. §1-21 of the Code of Ordinances of the Town of Black Mountain states that any act that is made unlawful by an ordinance is punishable by fine or imprisonment. For those, the "source" stated is "Code §1-21." Others recite that they are punishable as a misdemeanor or as provided in N.C.G.S. §14-4, and for those the source is set out as "Stated." Others provide no remedy, and those are made misdemeanors by the language of N.C.G.S. §14-4, and for those the source is stated as "NCGS §14-4."
