ORDINANCES

- 1. <u>Sec. 10.99-</u> Unless provided otherwise, a violation of a Town ordinances is a misdemeanor punishable by a fine not exceeding \$50.00 or by imprisonment not exceeding 30 days.
- 2. Sec. 30.38- Makes it illegal to tear or deface a Town ordinance.
- 3. Sec. 32.04- Makes it illegal for a Town employee to violate the Personnel Policies.
- 4. Sec. 32.05- Makes it illegal for a Town employee to accept favors or gifts.
- 5. <u>Sec. 32.07-</u> Makes it illegal to use Town property for personal purposes.
- 6. Sec. 32.40- Makes it illegal to engage in political activity while on duty.
- 7. Sec. 50.03- Makes it illegal to allow garbage to accumulate on private property.
- 8. <u>Sec. 50.10 (C)-</u> Makes it illegal to dispose of dangerous garbage such as broken glass in an unsafe manner.
- 9. Sec. 50.12- Makes it illegal to burn or bury garage.
- 10. Sec. 50.14- Makes it illegal to interfere with garbage receptacles.
- 11. <u>Sec. 50.19-</u> Makes it a misdemeanor to violate the garbage disposal ordinances (each day is a separate offense).
- 12. Sec. 50.28- Makes it illegal to place any unauthorized substance in the Town landfill.
- 13. <u>Sec. 51.03-</u> Makes it illegal to tamper with the Town utility systems or to improperly connect to the systems.
- 14. <u>Sec. 51.07-</u> Makes it a misdemeanor to connect to Town water after being disconnected for nonpayment without Town authorization.
- 15. Sec. 55.81- Makes it illegal to violate a pretreatment permit (regarding the sewer system).
- 16. <u>Sec. 70.16-</u> Makes it illegal to disobey the lawful order of a police officer or fire department official.
- 17. Sec. 90.03- Makes it unlawful to abandon vehicles in the Town limits.
- 18. <u>Sec. 90.04-</u> Makes it unlawful to possess a nuisance vehicle (one that constitutes a health hazard).
- 19. Sec. 90.05- Makes it illegal to possess a junked vehicle.
- 20. Sec. 90.15- Makes it illegal to remove an impounded vehicle.
- 21. Sec. 91.01- Makes it illegal to mistreat animals or engage in animal fighting.
- 22. <u>Sec. 91.03-</u> Makes it illegal to keep birds/fowl that are loud enough to disturb the peace or to allow chickens to run at large, or to keep more than 20 chickens or 1 rooster, or to raise chickens for commercial purposes.
- 23. Sec 91.04- Makes it illegal to possess pigeons unless in a cage.
- 24. Sec. 91.05- Makes it illegal to possess hogs.
- 25. Sec. 91.07- Makes it illegal to possess wild or vicious animals.
- 26. <u>Sec. 91.08-</u> Makes it illegal to possess more than 3 dogs or 3 cats unless properly licensed as a kennel or a farm.
- 27. Sec. 91.15- Makes it illegal to allow dogs to run at large and to tether dogs.
- 28. Sec. 91.16- Makes it illegal to possess a dog in heat unless properly housed.
- 29. Sec. 91.18- Makes it illegal to possess a dog that creates a nuisance.

- 30. Sec. 91.99- Makes it a misdemeanor to violate the Town animal ordinance.
- 31. Sec. 92.99- Makes it illegal to violate any regulations instituted in a State of Emergency.
- 32. Sec. 93.08- Makes it illegal to burn any materials without a proper permit.
- 33. Sec. 94.15- Makes it illegal to create loud and disturbing noises.
- 34. Sec. 94.20- Makes it illegal to possess loud animals that disturb the peace.
- 35. <u>Sec. 95.45</u> Makes it illegal to obstruct a public street or public place or sleep in a public place.
- 36. Sec. 95.50- Makes it illegal to place debris, in public streets or sidewalks.
- 37. Sec. 95.99- Makes it illegal to violate the Streets and Sidewalks ordinances.
- 38. Sec. 96.05 and 96.06- Make it illegal to violate Wateree Park ordinances.
- 39. Sec. 97.03- Makes it illegal to violate the Curfew ordinances.
- 40. Sec. 97.05- Makes it illegal for custodians to allow violation of the Curfew ordinances.
- 41. Sec. 97.07- Makes it illegal to aid or abet a curfew violation.
- 42. Sec. 97.09- Makes it a class III misdemeanor to violate the Curfew ordinances.
- 43. Sec. 130.01- Makes it illegal to discharge a firearm in the Town limits.
- 44. Sec. 130.02- Makes it illegal to damage Town property.
- 45. Sec. 130.04- Makes it illegal to carry a concealed weapon on Town properties.
- 46. Sec. 151.22- Makes it illegal to disobey orders to comply with the Town building code.
