## TOWN OF CANDOR LIST OF ORDINANCE OFFENSES PUNISHABLE AS MISDEMEANORS

<u>USE OF WEAPONS, PROJECTILES AND ANIMAL TRAPS</u>: Unlawful for any person to shoot or discharge any gun, pistol, firearm, compressed air rifle or pistol, spring gun or pistol, or any other device that expels a shot or pellet with force. Unlawful to shoot or discharge, by bow or otherwise, arrows or similar projectiles. Unlawful to trap domestic animals.

<u>SPEED LIMITS AND OTHER TRAFFIC VIOLATIONS</u>: Unlawful to operate motor vehicle than specified speeds in specified areas, pass on the right where prohibited, etc.

COOKING AND EATING ESTABLISHMENTS: Unlawful to erect eating or perishable merchandise establishments on the streets.

BLOCKING STREETS: Unlawful to erect buildings or cultivate crops in streets.

<u>PUBLIC INTOXICATION</u>: Unlawful to go upon streets or public places in a drunken condition.

NUISANCES: Unlawful for owner of dwelling unit to repair, alter or improve the property after being ordered to do so by the inspector.

SALE OF ALCOHOL: Unlawful to sell alcohol on Sundays.

BIRDS: Unlawful to trap, shoot or hunt birds.

STORAGE OF GASOLINE OR FUELS: Unlawful to build bulk plant for storage of gas, kerosene, or fuel oil.

FIRE ZONE: Unlawful to build or repair wood structure in fire zone.

NOISE: Unlawful to create loud and disturbing noise.

<u>PUBLIC URINATION AND DEFECATION</u>: Unlawful to willfully urinate or defecate in public.

<u>PUBLIC CONSUMPTION OF ALCOHOL</u>: Unlawful to consume beer or unfortified wine in public.

JUNKED OR ABANDONED VEHICLES: Unlawful for owner of vehicle or property where vehicle lies to fail to remove it or place it in proper location. Unlawful to remove vehicle from impound without paying all fees.

<u>LIVESTOCK</u>: Unlawful to keep or maintain livestock (cow, horse, mule, pony, sheep, goat, pig, hog, poultry, or other livestock). Unlawful to slaughter livestock.

WILD OR VICIOUS ANIMALS: Unlawful to keep, own or possess a wild or vicious animal.

<u>DOGS</u>: Unlawful to fail to comply with order of abatement or ordinance.

GAME ROOMS OR POOL HALLS: Unlawful to violate ordinance regulating operation of game rooms and pool halls. Unlawful to operate slot machine or gambling device.

**ZONING**: Unlawful to violate zoning ordinance or fail to comply with orders.

WATER AND SEWER USE: Unlawful to comply with pretreatment and grease control ordinance.
