53.13	Continuing a violation beyond the time limit provided for in the notice of violation and §53.06.
54.04	Not complying with a scheduled water use program or outright ban on Class 3 uses during a water emergency.
54.05	Not complying with water shortage emergency measures.
98.03	Creating or assisting with the creation of any unreasonably loud noise.
98.05	Engaging in any of the enumerated unreasonably loud activities.
100.01	Failure to post assigned street numbers on the property.
100.02	Failure to comply with the minimum height of numbers placed on a house, building, mobile home, or unit.
100.03	Display of numbers in script instead of numeric font.
100.04	Failure to maintain the visibility of building numbers.
100.05	Failure to post the required property number and lot number sites in a mobile home park.
100.06	Failure to post property numbers that contrast with the color of the building upon which they are fixed.
100.07	Failure to prevent obstruction of building numbers.
100.08	Activation of a public utility account without first displaying identifying street address numbers.
112.30	Operation of for-profit pool or billiards tables without a license. Operation of licensed tables outside the specified hours.
112.31	Plumbing without a license.
112.32	Working as an insulation contractor without a license.
115.02	Peddling, soliciting, or transient vending without a license.
115.08	Failure of a peddler, solicitor, or transient vendor to display badge or permit.
115.09	Wearing or usage of a badge or permit by someone other than the permittee.
115.10	Failure to surrender a revoked permit or badge.
115.12	Engaging in peddling or soliciting outside the prescribed hours. Entering upon a premises with a "No solicitors" or similar sign. Engaging in transient vending on property without written permission of the owner. As a permit holder, being aggressive, threatening, or intimidating. Failure to display badge in an easily observable way. Failure to present badge or permit when requested by a police officer.
115.14	Violating any provision of this chapter or any term or condition of a permit issued pursuant to this chapter.
152.10	Occupancy or permitting occupancy by another or use as a human habitation any dwelling or dwelling unit, which does not comply with all of the minimum standards of

152.110	Failure to comply with the minimum standards for structural condition of dwellings or dwelling units.
152.12	Failure to comply with the minimum standards for basic equipment and facilities in dwellings and dwelling units.
152.13	Failure to comply with the minimum standards for ventilation in dwellings and dwelling units.
152.14	Failure to comply with the minimum standards for space, use, and location applicable to dwellings and dwelling units.
152.15	Failure to comply with the minimum standards for safe and sanitary maintenance applicable to dwellings and dwelling units.
152.16	Failure to comply with the minimum standards for control of insects, rodents, and infestations in dwellings and dwelling units.
152.26	Failure to have at least one water closet, lavatory basin, and bathtub or shower properly connected to an approved water and sewer system and in good working condition supplied with hot and cold water. Failure to have same located within a room or rooms which afford privacy, are separate from habitable rooms, are accessible from a common hall, and are accessible without going outside a rooming house.
152.27	Failure to have every room occupied for sleeping purposes by one occupant containing a minimum of 70 sq. ft. Of floor area and every room occupied for sleeping purposes by more than one occupant containing at least 50 sq. ft. of floor area for each occupant 12 years old over and 35 sq. ft. for each occupant under 12 years of age.
152.28	Failure to maintain the sanitary maintenance of walls, floors, and ceilings and every other part of the rooming house.
152.36	As an occupant, failure to give access to any part of a dwelling or dwelling unit and its premises at a reasonable time for the purposes of making repairs or alterations as are necessary to effect compliance with this chapter.
152.39	Occupancy of a condemned dwelling or dwelling unit.
152.44	As the owner of a dwelling or dwelling unit, failure, neglect, or refusal to repair, alter, or improve, or to vacate, close, and remove or demolish same upon order of the Inspector.
153.010	Failure to keep a nonresidential building or structure free of all conditions that are dangerous and injurious to public health, safety, and welfare.
153.027	Occupancy or knowingly allowing the occupancy of a condemned nonresidential building or structure.
153.035	As the owner of a nonresidential building or structure, failure, neglect, or refusal to repair, alter, improve same or to vacate and close, remove, or demolish same upon order of the Inspector. Alternatively, occupancy of same after the time prescribed in such an order by the Inspector.
