

Town of Cleveland Ordinances

Section	Description
10.09	Prohibits a person from defacing any of the town's ordinances.
40.15	Prohibits any excavation or opening of a ditch, trench, tunnel along, across or under any street, sidewalk without a written permit
40.17	Requires street repair after excavation
40.18	Leaving excavations unprotected
40.19	Streets not to be damaged by tractors or harrows
40.20	Prohibits sidewalks from being built without a written permit from the Town
40.21	Requires written consent of the Town to move any house or building and requires deposit to cover damage done to streets or sidewalks
40.22	Prohibits tampering or defacing any bridge, culvert, ditch, drain, sign, sign post, street light, traffic signal, bulletin board or other Town property
40.23	Prohibits construction, repair, altering any driveway on the public streets, unless a written permit is issued by the Town
41.02	Unlawful to throw or deposit any garbage or refuse on any public or private property except in approved containers
41.03	Unlawful to burn or bury any garbage for the purpose of disposal
41.04	Unlawful for any person to permit garbage or refuse to accumulate on premises longer than reasonably necessary
41.05	Garbage containers required for disposal
41.06	Garbage practices of Town to be followed
41.08	Unlawful to damage, displace or otherwise interfere with garbage containers or their contents except by owner permission
42.02	Burial permit required to be buried in Town cemetery. All graves to be dug under Town supervision.
42.04	Approval of Town required to plant or cut any tree, shrub, flower in cemetery
42.05	Prohibits any rubbish or waste to be deposited in cemetery. No person shall disturb the quiet, destroy any tree or plant, trespass or commit any immoral act in cemetery
43.06	Prohibits damage or removal of any tree or plant in the Town Park. Prohibits defacing or damaging any part of the Park, buildings, signs or equipment
43.07	Prohibits disposal of refuse or garbage at the Park except in containers designated for such purpose.
43.09	Prohibits the owner to allow any dogs or other animals to run at large at the Park.
43.10	Prohibits camping in the Town Park except when permit is issued by Town.
43.11	Prohibits the playing of football, golf, baseball, etc. in the Park except in specifically designated areas.
43.12	Prohibits the riding of horses in the Park.
43.13	Prohibits hunting within the Park.
43.14	Prohibits weapons within the Park unless properly permitted by NCGS 14-415.11. Prohibits explosives within the Park.
43.15	Prohibits building fires or discarding any lighted match, cigarette or other burning objects within the Park.
43.16	Prohibits smoking in any park structure.
43.17	Prohibits disorderly conduct within the Park

- 43.18 Prohibits gambling within the Park
- 43.19 Prohibits the public display or use of any alcoholic beverages within the Park
- 43.20 Prohibits the sale of merchandise, property or services within the Park without a permit
- 43.21 Prohibits the posting of advertisements within the Park
- 43.22 Prohibits sex offenders to enter or remain in the Town Park
- 50.04 Requires all owners of property within 200 ft of any Town water line to connect their premises to the Town water system.
- 50.10 Prohibits any connection to the Town's system of any water line outside of the Town without special permission of the Board
- 50.11 Prohibits unauthorized use of water
- 50.13 Prohibits unlawful use of water
- 50.15 Prohibits any person from defacing or destroying the property of the Town water system or in any way contaminate the Town water supply
- 50.16 Prohibits water meter tampering
- 50.22 Water Shortage Response Ordinance - Violations of ordinance shall be guilty of a misdemeanor.
- 51.04 Requires all owners of property within 200 ft of any Town sewer line to connect their premises to the Town sewer system.
- 51.09 Prohibits any connection to the Town's system of any sewer line outside of the Town without special permission of the Board
- 51.10 Prohibits the discharge of any solid or liquid into any sanitary or storm sewer at any manhole or any substance likely to obstruct or cause injury to same
- 51.11 Prohibits injury to sewer structures
- 51.12 Prohibits connection of any drains from roofs, surface drains, swimming pool drains to be connected or discharges into Town sewer lines
- 51.13 Prohibits drains from garages or other places which may discharge any oil or greased to be discharged into the sewer system.
- 51.15 Prohibits unauthorized use of sewer
- 61.02 Unlawful to operate a game room without a license
- 61.04 Prohibits gambling, profane language or employment of any person who has been convicted of unlawfully selling alcohol or narcotic drugs
- 61.05 Sets game room allowed hours, requires windows so that a clear view inside may be had from the street, adult on premise managing business
- 81.00 Animal Ordinance-dog declared a nuisance, cruelty to animals, interference with animal control officer, failing to abate nuisance
- 82.01 Littering prohibited on street or sidewalk or on any private property
- 82.02 Littering prohibited from vehicles
- 84.01 Unlawful to fire any gun in Town except a pellet or air gun no larger than a .24 caliber with conditions
- 84.02 Prohibits disturbance at or near any public entertainment or meetings
- 84.03 Prohibits damaging, defacing or trespassing on any property belonging to the Town.
- 84.04 Prohibits unnecessary noise that is unreasonably loud, disturbing such as loud automobile, radio steam whistle, loud speaker, etc.

- 84.05 Prohibits consumption of alcoholic beverages in any public place or public street, sidewalk or property owned by the Town.
- 84.06 Prohibits from riding or driving any horse or beast of burden or any motor vehicle on sidewalks.
- 84.07 Unlawful for any person to loiter, sleep or impede the flow of traffic at any building, sidewalks or streets owned by the Town.
- 84.08 Unlawful for any owner or occupant to have a well or excavation on premises to remain without an enclosure or covering to prevent falling into
- 84.09 Prohibits indecent exposure and public nudity
- 84.11 Prohibits begging or soliciting alms by forcing oneself upon another, within 100 ft of an entrance or exit of a bank, outdoor dining area, schools, after dark or under influence of alcohol or drugs, making false representation, on roadway, on private property after owner has asked person not to solicit
- 90 Building Regulations - Prohibits financial interest or conflict of interest of an officer of the Building Inspections Department
Prohibits the occupancy of a new or addition to a building without a certificate of occupancy for building and zoning regulations.
Failure to obtain building, plumbing, heating/air conditioning or electrical permit
- 91 Subdivision Ordinance-prohibits the subdivision of any land within the territorial jurisdiction without Town approval
- 92 Zoning Ordinance-If civil penalties for violation are not settled or paid, the violator shall be subject to criminal penalties the court may impose pursuant to NCGS 14-4
- 93 Flood damage Prevention Regulations - any violation or failure to comply, including violation of conditions and safeguards
