Chapter 52 § .001 et.seq.	Post-Construction Storm Water Control Regulations	Chapter describes administration procedures; standards; maintenance requirements for post-construction storm water control. Violations are punishable either through civil process or 14.4.
Chapter 70 §70.02	Traffic Control Sign and Devices	Unlawful to disobey traffic control device; unlawful to injure, deface traffic control device
Chapter 70 § 70.05	Avoiding an Intersection	Unlawful to drive through public or private property to avoid an intersection
Chapter 90 § 90.16	Abandoned Vehicles Prohibited; removal authorized	Unlawful for owner of vehicle to cause it to be abandoned
Chapter 90 § 90.29	Unlawful removal of Impounded Vehicle	Unlawful for any person to remove or attempt to remove vehicle from designated impound facility prior to paying fees
Chapter 91 § 91.06	Animals/Animal Control - Violations	Unlawful for any person to abandon; abuse; animal bites; maintain nuisance animals; fail to surrender animal; unlawfully kill or release an animal; fail to restrain animals; harbor strays; fail to remove feces. Civil penalties/criminal option.
Chapter 91 § 91.07	Rabies Inoculation	Unlawful to have animal not vaccinated for rabies and to provide proof of inoculation. Civil penalties/criminal option

Chapter 91 § 91.12	Interference with Animal Control Officer	Unlawful to interfere with animal control officer

Chapter 93 § 93.02	Possession or Consumption of Alcoholic Beverages	Unlawful to consume alcoholic beverages on Town property without a permit.
Chapter 93 § 93.03	Controlled Substance Prohibited	Use, possession, distribution of controlled substances unlawful
Chapter 93 § 93.04	Littering and Dumping on Park Property	Unlawful to dump garbage or other waste on park property.
Chapter 93 § 93.05	Driving and Parking in Un designated Areas	Unlawful to park or drive in undesignated areas in town parks.
Chapter 93 § 93.06	Pets	Unlawful to have pets in town park areas where pets are expressly forbidden.
Chapter 93.07	Hours of Operation	Unlawful to use park outside of designated hours.
Chapter 93.08	Prohibited Activity	Airborne vehicles; fuel powered models; and golfing is prohibited in Parks.

Chapter 93.10	Weapons, Explosives, Fire.	No person may carry, possess or discharge any type of firearm, explosive, air gun, or other deadly weapon on park property unless authorized by permit; no fires.

Chapter 93.12	Conduct	No person shall willfully and intentionally disobey a lawful order of police; or authorized park employee or volunteer; nor shall a person use abusive language, unreasonably disturb others, under the influence of intoxicants, breach the peace.

Chapter 94.01 and 94.02	Trash and Debris on streets and sidewalks	Unlawful to deposit trash, dirt, or liquids on streets and sidewalks; construction sites must remove dirt, construction materials and other debris from streets and sidewalks.
Chapter 94.34	Display of Incorrect Street Number; Defacing of	Unlawful to allow or cause an incorrect street address to remain on a building; remove, obliterate or deface street address numbers.
Chapter 94.50, 94.55, 94.56	Utility Right-of-Way Use	Unlawful to make, excavate, fill, repair or close a utility without necessary permits; close any portion of the public right-ofway without a utility work permit.
Chapter 95.15	Maintenance of Storm Water Systems	Unlawful to cause any sewer or storm water system to be partially or completely blocked or damaged.
Chapter 95.20	Storm Water Drainage System	Unlawful to alter any storm water drainage system within any publicly dedicated right-ofway or easement without proper permitting.
Chapter 97 § 97.04	Graffiti Unlawful	Unlawful to deface public or private property; to possess implements of graffiti by a minor on school or private property without permission; unlawful for any person to possess implements of graffiti upon public property or within 50 feet of an underpass or other infrastructure without permission from town.
Chapter 98 § 98.01	Camping and other Activities Prohibited	Unlawful to camp on public property; unlawful to light or use campfire on public property without a permit.
Chapter 98 § 98.02	Possession of Obstruction Devices Prohibited; Placing Objects in Roadway, Public Right of Way Prohibited	Unlawful to possess any obstruction object or instrument with intent to obstruct public ROW; unlawful

Chapter 98 § 98.03	Possession and Dispersal of Noxious Substances	to attach to another person with intent to obstruct pedestrian or vehicular movement; Unlawful to possess noxious substance with intent to interfere with lawful assembly; unlawful to throw or emit a projectile or otherwise disperse
Chapter 98 § 98,04	Police Lines and Barricades	a noxious substance.  Unlawful to cross police line or barricade.
Chapter 98 § 98.05	Kindling Bonfires	Unlawful to set a fire on a public street, public property or ROW unless expressly allowed by permit.
Chapter 98 § 98.06	Attachments to Public and Private Property	Unlawful to hang, fasten or attach anything to public or private property without express permission of owner of the property.
Chapter 99 § 99.05	Regulations	During an event that is declared "extraordinary" by the Town it is unlawful to:  Operate a vehicle or float in the area without a permit; Throw things from vehicles in the area without a permit; To intentionally possess, carry or control: A bar, chain, other object etc. capable of causing injury if thrown Aerosol container, spray gun or soaker device; Paint gun; Backpack or bag intended to conceal a weapon or prohibited item; Sharp bladed object Hammer or crow bar; Pepper spray or other irritant; Body armor worn with intent to delay, obstruct or resist law enforcement;

Chapter 116 § 01	Peddlers and Hawkers: General Provisions	Unlawful, without prior permission, to enter onto private property for the purpose of soliciting orders for goods. (charitable solicitation excepted). Unlawful to sell or offer for sale goods on a public street without a permit.

Chapter 117 § .10	Adult Business: Prohibitions Regarding Minors	Unlawful for owner, operator or employee of a sexually oriented business to knowingly permit or allow admittance of a minor or to sell goods to a minor or employ a minor.
Chapter 117 §117.11	Adult Business: Regulations pertaining to adult live entertainment businesses	Unlawful to fail to comply with regulations of ordinance pertaining to Adult live entertainment; Unlawful to engage in or perform adult live entertainment in violation of the Ordinance.

Chapter 117 § .12	Regulations Pertaining to Adult Mini Motion Picture Theaters	Unlawful to fail to comply with Ordinance regulating Mini Motion Picture Theaters
Chapter 117 § .13	Regulations Pertaining to Clothing Modeling Studios	Unlawful to fail to comply with Ordinance regulating Clothing Modeling Studios; unlawful to model in violation of the ordinance.
Chapter 130 § 01	Firearms	Unlawful to discharge a firearm.  (except law enforcement and defense of person or property)
Chapter 130 § 02	Explosives	Unlawful for any person to explode or cause to explode dynamite, bomb or explosive.
Chapter 130 § 03	Fireworks	Unlawful to discharge fireworks or pyrotechnics on streets or in a public space without a permit.
Chapter 130 § 04	Crowds and Assemblies	Unlawful for any person to commit a breach of the peace or engage in disorderly conduct within in town; congregate so as to impede or interfere with free passage of movement; unlawful to refuse to disburse when directed.
Chapter 130 § .05	Disorderly Conduct	Unlawful to: Act in a violent manner whereby others are placed in fear; Endanger lawful pursuits; Cause or provoke a fight; Assemble for purposes of causing a fight Jostle or roughly crowd or push people Be a member of a crowd gathering for an unlawful purpose; Be a member of a crowd gathering for illegal gaming; Frequent a public place with intent to engage in an illegal and fraudulent scheme; Utter in anger lewd or obscene words; Frequent a place where illegal gaming or the illegal sale or

		possession of alcohol or controlled substances is allowed; Use 'fighting words"
Chapter 130 § 130.06	Loitering – For purposes of drug Activity	Unlawful for a person to remain or wander about in a public place manifesting the purpose to engage in a violation of any NCCSA (GS 90 Article 5)
Chapter 130 § 130.07	Loitering – On Streets	Unlawful to habitually loaf or loiter in such a way so as to obstruct free passage.
Chapter 130 § 130.08	Aggressive Panhandling Prohibited	Unlawful to beg or solicit alms in an aggressive manner in any place open to the general public; in a public transportation vehicle or at a bus stop; in exchange for washing windows while in traffic.
Chapter 130 § 130.09	Interfering with Police	Unlawful to interfere with police
Chapter 130 § 130.10	Police and Fire Alarm and Signals, Unauthorized use	Unlawful to carry or use whistles, horns or sirens similar in appearance and sound to those used by police and fire.
Chapter 130 § 130.11	Congregating Near Fire	Unlawful to congregate in a manner that interferes with activities of the fire department.
Chapter 130 § 130.12	Impersonation of Town Officers and Employees	Unlawful to impersonate officer or employee of the Town.
Chapter 130 § 130.13	Failure to Pay Transportation Fare	Unlawful to fail to pay for public conveyance.
Chapter 130 § 130.14	Firearms; Display while under the influence of an impairing substance	Unlawful to display firearm while impaired
Chapter 130 § 130.15	Damaging Property – Public Property on Streets and Places of Town	Unlawful to damage or deface public property
Chapter 130 § 130.16	Damaging Property – Utility Systems, Police Alarm Systems and the Like	Unlawful to interfere with valve, meters, box, manhole covers, fire hydrant, police or fire alarm box, traffic signal, etc.

Chapter 130 § 130.17	Damaging Property – Signs and the Like	Unlawful to deface, damage, knock down or remove signs, signals, devices authorized by the Municipal Ordinances
Chapter 130 § 130.18	Trespass on Town Property	Unlawful to enter upon town property without the direction or supervision of the governing body.
Chapter 130 § 130.19	Trespass – On Business Premises	Unlawful to loiter, whether in or on any type vehicle or afoot, in or upon the premises of any business without permission of owner of business.
Chapter 130 § 130.20	Assembling so as to Block Passage on Streets	Unlawful to assemble so as to obstruct sidewalks or streets.
Chapter 130 § 130.21	Playing upon Streets, Sidewalks and Public Places	Unlawful to engage in game or recreational activity on a street or sidewalk in a manner so as to impede pedestrian traffic, endanger property, endanger life and limb, prevent full use of sidewalk or public space, breach the peace or constitutes unreasonable annoyance.
Chapter 151 § 151.01	Compliance Required Prior to House moving	Unlawful to move house without a permit.
Chapter 151 § 151.04	Removal of Signs, Wires and the Like	Unlawful to remove street signs boards, lamps, lamp posts, etc. while moving a house without permission.
Chapter 154 § 154.18	Flood Damage Prevention: Compliance	No structure or land shall be located, extended, converted, or structurally altered without compliance with the Ordinance.
