Imposition of mayoral prohibitions and restrictions

Permits relating to deposit or discharge industrial waste, compliance, and disconnection and reconnection based on permit approval.

Prohibition of depositing specified waste materials into any town sewer. Arrangements may be made to pretreat and dispose of waste in sewers give special agreement

Prohibiting the discharge of storm water, surface water, ground water, roof runoff, subsurface drainage, cooling water, or unpolluted industrial or commercial process water.

Water discharged under prespecified conditions, may be conditionally admitted, but exceeding siad limits, the discharging individual must contact the town and receive approval, along with providing notice.

Requirement of storage tanks, control manholes, interceptors and traps, and plans for their construction.

Persons riding shall remain in the vehicle

It shall be unlawful to hnag any gate across the sidewalk.

No person shall block sidewalks using sheds and awnings

Tree limbs shall not block the path

No plantings shall be parked within 50 feet from the corner of any streets

Goods and merchandise may not be set up on the diwalk without

Excavation and sidewalk construcion regulations

Protection of excavations of sidewalk regulations

Designating tree species acceptable for use in the town, requiring landscape plans for municipal parks shall be approved on a case by case basis.

Location and spacing of street trees to minimize hazards and interference.

Public tree care as it relates to planting, pruning, maintenance, and removal of trees, plants, and shrubs, preventing interference with public passage

Construction which pose a hazard to public owned trees, chemical spillage, location of new driveways, soil compaction and mechanical injury, branches pruned from publicly-owned plants.

Tree topping in unlawful

Removing stumps so as not to project above the surface of the ground

Unlawful to engage in the occupation of pruning, treating, or removing streets to procure a license.

Town Council may review the decisions of the Town Tree Committee.

Unlicensed vehicles shall not be run in recreational areas.

Forbidden to place or erect advertising or billposting

Town Manager

Discharge of firearms in town parks

unlawful to damage property

Animals shall not run at large in the park

Unlawful to wound, injur, trap or kill an animal in any park owned by the town

Unlawful to peddle or solicit in parks without written permission

Alcoholic beverages unlawful in parks

Sports activities are prohibited outside of designated area, and shall never damage park structures or equipment

No excavation without express permission

Trash may only be deposited in containers as provided, dumping and littering is prohibited

Food truck location, permits, and requirement regulations

Pool or billiards, bowling alley orgames for charge require license issued by the city

License must be posted in amusement businesses

Requirements regarding proper conduct on amusement business properties.

Advertising shall not by placed on public property

No one shall passout or scatter handbills at houses, businesses, screen doors, or under doors.

unlawful for loudspeaker and amplifiers used without town permit

When a loudspeaker or amplifier is being operated with a permit, no one shall interfere

Peddlers or solicitors must be invited to enter upon private residences

Evasion of taxes imposed on gross receipts of vehicles.

Tax Collector must administer and collect for leases and rental entities, as well as promulgate additional lawful rules and regulations

Payment of taxes for entities required.

Taxicab rates for town limits and their current schedule.

Tax owners or operators shall pay a tax annually.

Parking taxi stands established

Certificate of convenience from Town Council necessary to operate a taxicab

Certificate of convenience processing, hearings, and public convenience as it relates to taxicabs.

Issuance of certificates for driving in the public right-of-way.

Application of renewal

Failure to begin operation of taxicab certification

Substitution vehicles, permissible.

Certificate not transferable without consent of Town Council.

Revocation of certificate.

Taxicabs prohibited from taking passengers more than 5 miles for hire without a permit.

Application requirements, and the report thereof to the Town Council

Permits may be granted to the Town Council, so long as their record is clean

Permit for taxicab drivers must be displayed.

Suspension of permit, suspension must be given notice.

Revocation of permit

Unlawful to beg or solicit in the general public

It shall be unlawful to fish or jump from bridges in the town

Prohibiting the damage of public and city property, trees, streets

No anchoring a ship to a dock abutting a residential district, and docking boat size and location restrictions

Unlawful to block drainage, creek or stream

Unlawful to discharge a firearm in the town

Unlawful for any person to tamper with glass on city property

Loitering prohibited in public spaces

Noise violations, relating to loud, disturbing or unnecessary noise does not apply to periods following disaster announcement.

Unlawful to shoot projectiles except in ranges or galleries

Unlawful to operate a minibike, moped, motorcycle in public parks

Train regulations, including train speed limits, crossing improvements, not blocking crossings for more than five minutes

Spitting on sidewalks prohibited

Maintain property standards by keeping weed removal

Unlawful to swim from public property

Unlawful to skateboard in park areas

Unlawful to place graffiti

Possession of graffiti implementation by a minor

Perpetrator of graffiti violation

Unlawful to display or possess dangerous weapons as designed

Unlawful to consume malt beverages or unfortified wine

Unlawful to possess open containers in public streets

Possession of alcohol during special events, unless a resolution making provisions for alcohol at the event

Possession of malt beverages permitted only with appropriate permits

Curfews implemented to prevent victimization and promote welfare

Definitions regarding Curfew.

Offenses committed by minors by remaining in public places or premises during restricted hours

Juvenile curfew exceptions

Enforcement by police officer, given that no exception is granted.

Declared in town dwellings which are unfit for human habitation, and establishing minimum standards of fitness.

Definitions relating to dwelling unfit for habitation

Minimum standards of fitness, and forbidden to occupy dwelling units.

Minimum standards for structural condition of buildings

Minimum standards for plumbing, heating, and electricity

Ventilation standards for habitable rooms, including bathroom and water compartments

Minimum standards for room size, ceiling height, floor area, cellars are not permissible for living purposes and basements.

Minimum standards for exterior foundation, walls, and roofs, interior floors, walls and ceilings, windows and doors, stairs porches and appurtenances, bathroom floors, supplied facilities, drainage, noxious weeds, egress.

Minimum standards for screens, rodent control, infestation prevention, rubbish storage and disposal, and garbage disposal

Minimum standards for bath facilities, sleeping, sanitary conditions and facilities

Inspection of dwelling, dwelling units, rooming house, or rooming units

Role, powers and duties of Building inspector

Procedure for investigation, notices, and hearings for repair, vacation and closure or removal or demolition of unfit dwellings

Methods of service of complaints and orders

Occupation of a building posted as unfit for human habitation

Costs a lien on premises, sale of personal property in connection with nuisances or abatement

Occupant refusing to vacate a dwelling, appeals, petition by owner

Zoning Board of Adjustments to hear appeals

Properties deteriorated by neglect so as to violate minimum livability standards, notice and complaints, orders, undue economic hardship, notices, remedies, and its effect on other provisions.

Higher standards and more stringent requirements for the promotion and protection of the health and safety of the town residents of the town shall prevail.

Purpose of mobile home and manufactured home regulations

Regulations that govern manufactured home and mobile homes

Definitions governing manufactured home and mobile homes

Manufactured homes and mobile homes with a valid HUD inspection with current taxes paid are permitted, they may not be older than 15 years before present date and a residence, and if constructed before 1-1-1977 may not be used as a residence.

Town inspection department can withhold permits from homes not complying with mobile home and manufactured home standards
