ORDINANCES

- 1. <u>Sec. 160A-80 (B)-</u>Makes it illegal (a misdemeanor) to swear falsely under oath during a Council investigation.
- 2. <u>Sec. 160A-175(B) and Sec. 10.99-Makes it a misdemeanor to violate any Town ordinance.</u>
- 3. Sec. 32.19 (B) and Sec. 32.99(B)-Makes it a misdemeanor to make a false statement on a business license application.
- 4. <u>Sec. 32.28 and Sec. 32.99(C)-</u> Makes it illegal (a misdemeanor) to do business in the Town without paying a license tax.
- 5. <u>Sec. 33.20 (G)-</u> Makes it illegal to violate any restrictions imposed by the Mayor during a State of Emergency.
- 6. <u>Sec. 33.33-Makes</u> it illegal to congregate on any street or alley near a fire in a manner which would interfere with the Fire Department.
- 7. <u>Sec. 33.34-</u> Makes it illegal to interfere with or hinder the Fire Department when the Fire Department is discharging its duties, to loiter at the Fire Department or interfere with the Fire Department's apparatus/vehicles.
- 8. Sec. 33.41- Make it illegal to tamper with a fire hydrant.
- 9. Sec. 50.03- Makes it illegal to dispose of garbage except in Town approved containers.
- 10. <u>Sec. 50.05 and 93.04-</u> Makes it illegal to allow accumulation of garbage on private property.
- 11. Sec. 50.06- Makes it illegal to burn or bury garbage without a permit.
- 12. Sec. 50.08- Makes it illegal to interfere with other's garbage containers.
- 13. <u>Sec. 51.34 and Sec. 51.51-</u> Makes it unlawful (misdemeanor) to connect to or interfere with the Town's water system except as allowed by Town regulations.
- 14. Sec. 51.67- Makes it illegal to violate the restrictions of a Stage II Water Shortage.
- 15. Sec. 51.68- Makes it illegal to violate the restrictions of a Stage III Water Shortage.
- 16. Sec. 52.14- Makes it unlawful to discharge certain substances into the sewer system.
- 17. Sec. 52.16- Makes it illegal to damage the sewer system.
- 18. <u>Sec. 70.03-</u> Makes it illegal not to comply with the lawful orders of the police or fire department.
- 19. Secs. 70.15, 70.71 and 71.17- Make it illegal (misdemeanor) to disobey traffic signage.
- 20. Sec. 70.19- Makes it illegal to displace unauthorized traffic signage.
- 21. Sec. 70.20- Make it illegal to disturb traffic signage.
- 22. <u>Title IX, Sec. 1-10-</u> Makes it unlawful to permit animal fighting or possess animals for fighting.
- 23. <u>Title IX</u>, <u>Sec. 1-11-</u> Makes it unlawful to possess wild or exotic animals.
- 24. Title IX, Sec. 1-10- Makes it unlawful to carryout cruel treatment against animals.
- 25. <u>Title IX</u>, <u>Article V</u>, <u>Sec. 1-40 (H) and (J)-</u> Makes it illegal to not possess or to switch rabies tags.
- 26. <u>Title IX</u>, <u>Article V</u>, <u>Sec. 1-40 (N) and (O)-</u> Makes it unlawful to kill or release an animal under rabies observation or to fail to surrender it.

- 27. <u>Title IX</u>, <u>Article V</u>, <u>Sec. 1-40 (N) and (O)-</u> Makes it unlawful to provide proof of vaccination.
- 28. <u>Title IX</u>, <u>Article VI</u>, <u>Sec. 1-60-</u> Makes it unlawful to keep chickens/rabbits if not in sanitary conditions.
- 29. <u>Title IX</u>, <u>Article VI</u>, <u>Sec. 1-62-</u> Makes it unlawful to graze cattle/horses/any animal on public lands.
- 30. <u>Title IX</u>, <u>Article VI</u>, <u>Sec. 1-63-</u> Makes it unlawful to sell animals in the public right-of-way.
- 31. <u>Title IX</u>, <u>Article VI</u>, <u>Sec. 1-71-</u> Makes a violation of any animal ordinance a misdemeanor.
- 32. Sec. 92.14- Makes the removal of impounded vehicles illegal.
- 33. Sec. 93.01 and 93.03- Makes unnecessary noise, riots, public disturbances unlawful.
- 34. Sec. 93.02- Makes breaking police lines unlawful.
- 35. Sec. 94.11- Makes it illegal to disturb a cemetery.
- 36. Sec. 94.13- Makes it illegal to dispose of trash in a cemetery.
- 37. Sec. 95.33- Makes it unlawful to interfere with the Town Tree Board
- 38. <u>Sec. 96.15-</u> Makes it unlawful (a misdemeanor) to congregate in public streets/sidewalks if it impedes traffic.
- 39. Sec. 96.16, 96.18 and 96.20- Makes it illegal to display merchandise on or build structure on sidewalks within seven (7) feet of the curb.
- 40. Sec. 96.19- Makes it illegal to repair vehicles in the street except in an emergency.
- 41. Sec. 96.30 and 96.31- Makes it illegal to litter.
- 42. Sec. 96.34 and 130.02- Makes it illegal to drink alcohol in public places.
- 43. Sec. 97.02- Makes it illegal to organize a parade without a permit.
- 44. Sec. 97.04- Makes it illegal to bring weapons or animals to parades.
- 45. Sec. 97.07- Makes it illegal to interfere with a parade.
- 46. Sec. 110.15-Makes bowling alleys and pool rooms illegal unless a license is obtained.
- 47. Sec. 110.36- Makes carnivals and games of chance illegal.
- 48. Sec. 111.03- Makes door to door peddling illegal without the consent of the homeowners.
- 49. Sec. 112.03- Prohibits the sale of anything other than personal property at a yard sale.
- 50. <u>Sec. 112.99-</u> Makes yard sales illegal (misdemeanor) except as conducted pursuant to Town regulations.
- 51. Sec. 130.01- Makes it illegal (misdemeanor) to discharge a firearm in the Town limits.
- 52. Sec. 130.03- Makes it illegal to disturb public meetings/gatherings.
- 53. Sec. 130.04 and 130.05- Makes it illegal to injure public or private property.
- 54. <u>Sec. 130.17-</u> Makes it unlawful (delinquency and misdemeanor) for youth/adults to violate the Town curfew/or assist with violations.
- 55. Sec. 151.38- Makes it illegal (misdemeanor) to violate the Town Building Code.
- 56. Sec. 152.999- Makes it illegal (misdemeanor) to violate Town Zoning Regulations.
