Ordinances Punishable by Misdemeanor

Chapter 32, Penalty 32.01 State of Emergency

The ordinance authorizes and empowers the Mayor to declare a State of Emergency by proclamation if the emergency endangers the lives, safety, health and welfare of the people in the Village.

Chapter 32, Penalty 32.04 Curfew

The proclamation prohibits anyone to appear in public in certain geographical areas at certain times during each 24-hour day the curfew applies.

Chapter 32, Penalty 32.05 Restrictions on Possession, Consumption or Transfer of Alcoholic Beverages

The proclamation prohibits the possession or consumption of any alcoholic beverage, including beer, wine and spirituous liquor other than on one's own premises, and may prohibit the transfer, transportation, sale or purchases of any alcoholic beverage within the area of the village described in the proclamation.

Chapter 32, Penalty 32.06 Restrictions on Possession, Transportation or Transfer of Dangerous Weapons and Substances

The proclamation prohibits the transportation or possession off one's own premises, or the sale or purchase of any dangerous weapon or substance unless by law enforcement.

Chapter 97, Penalty 96.02 Declaration of a Public Health Nuisance:

The Ordinance prohibits the owner of a lot to allow grass, weeds or vegetation to grow in excess of 12 inches.

Chapter 110, Penalty 110.06 Panhandling, Begging, Solicitation, Canvassing:

The ordinance prohibits any person to panhandle or beg within 20 feet of the entrance of any financial institution or automatic teller machine, outdoor dining area or outdoor merchandise area.

Chapter 110, Penalty 110.04 Solicitation:

The ordinance prohibits any person to solicit on private property where "No Soliciting" or No Trespassing" signs are posted.

Chapter 110, Penalty 110.05 Canvassing:

The ordinance prohibits any person to canvass on private property where "No Soliciting" or No Trespassing" signs are posted; on public sidewalk, public right-of-way or within a public park owned by the village; accosting another or by forcing oneself upon another within 20 feet of the entrance of any financial institution or automatic teller machine, outdoor dining area or outdoor merchandise

area; or solicit in a commercial establishment; touching a person being solicited without their consent or verbally communicate to them after dark.

Chapter 130, Penalty 130.02 Firearms:

This ordinance prohibits any person to discharge a firearm within the municipal limits of the village.

Chapter 130, Penalty 130.04 Discharging Firearms and Roadways:

This ordinance prohibits any person to discharge a firearm from any right-of-way, across a sidewalk, highway, street or other public vehicular area.

Chapter 130, Penalty 130.05 Minors and Firearms:

This ordinance prohibits any person, being a parent or guardian of any child under the age of 12 years to permit the child to have in possession or custody of or use in any manner a firearm whether loaded or unloaded.
