3-2030	Part 3, Chapter 2, Article B—Fire Protection Code (for enforcement of State Building Code related to fire prevention and safety)
3-2069	Part 3, Chapter 2, Article E—Automatic Fire Alarm Systems (for violation of regulations on installation, tampering, etc.)
3-3002	Part 3, Chapter 3, Article A—Emergencies (for violations where state of emergency declared)
4-2012	Part 4, Chapter 2—Solid Waste Management (for violations regarding dumping, landfill, etc.)
6-1075	Part 6, Chapter 1, Article C—Amusement Centers (for violations regarding operation of such)
7-1025	Part 7, Chapter 1—General Traffic Regulations (for violations of numerous local rules concerning motor traffic, parking, etc.)
7-1297	Part 7, Chapter 1, Article W—Golf carts (for violations of restrictions on places, times and circumstances of operation on public streets)

8-1001	Section only (Beer and wine regulations—for violations involving drinking or displaying alcoholic beverages)
8-1005	Section only (Loitering on public property)
8-2055	Part 8, Chapter 2—Animals (for violation of various regulations concerning keeping of or treatment of animals)
8-3020	Part 8, Chapter 3—Abandoned, Nuisance and Junked Motor Vehicles (for violations regarding junked or abandoned vehicles on streets or on private property)
8-4010	Part 8, Chapter 4—Nuisances Relating to Property (for violations related to maintaining nuisances on one's property after City demand/order to correct)
8-6010	Section only (Regulation of noise—for violation of limitations on excess or disturbing noises)
8-7006	Part 8, Chapter 7—Smoking/tobacco use in City buildings/vehicles
8-8006	Part 8, Chapter 8—Littering
8-9006	Part 8, Chapter 9—Possession/Display of Firearms (for violation of restrictions)
8-10013	Part 8, Chapter 10—Conduct and Nuisances in Parks/Recreational Facilities (for violation of certain rules of conduct on public property)
8-11005	Part 8, Chapter 11—Sex Offenders prohibited in certain areas
9-7032	Part 9, Chapter 7—Watershed Protection (for violation of regulations required by State and Federal law)
9-8029	Part 9, Chapter 8—Phase II Storm Water (for violation of regulations required by State and Federal law)
