SUBJECT: Bi-Annual Confidential/Fictitious Report for the Driver's License and License Plate Report and Private Plate Report Per N.C.G.S. §20-39.1

The Division of Motor Vehicles is required to submit a Bi-Annual Fictitious Report for Driver's License and License Plate Report and a Private Licenses Plate Report to the Fiscal Research Division of the North Carolina General Assembly.

- (1) The total number of Fictitious Driver License's Issued Report.
- (2) The total amount of Fictitious Plate's Issued Report.
- (3) The total number of Private Plate's Issued Report.

Pursuant to N.C.G.S §20-39.1(i), this report includes all of the information required under this statute for the bi-annual reporting period of Dec 1, 2018 through May 31, 2019. This report is given in the following three reporting segments.

Per General Statute 20-39.1(ii):

At no time shall the number of valid licenses issued under this subsection exceed two hundred nor shall the number of valid license plates issued under this subsection exceed one hundred twenty-five unless the Director of the State Bureau Investigations determines that exceptional circumstances justify exceeding those amounts. However, fictitious licenses and license plates issued to special agents of the State Bureau of Investigation, State alcohol law enforcement agents, and the Department of Defense shall not be counted against the limitation on the total number of fictitious licenses and plates established by this subsection and shall be renewable annually.
