To Whom It May Concern:

In accordance with Section 120-157.2(a) of the General Statutes of North Carolina as amended, the Town of Beech Mountain hereby notifies you of its intent to enter into a State Reserve Project Loan with the Division of Water Infrastructure in the North Carolina Department of Environmental Quality subject to the approval of the Local Government Commission, in the expected amount of \$2,870,000.

<u>Purpose of Project</u>: The purpose is to identify sewer deficiencies in seven identified areas and to complete improvements by means of rehabilitation, repair, or replacement.

<u>Scope of Project</u>: The project will rehabilitate or replace approximately 6,500 LF of 8" gravity sewer and 2,550 LF of 10" gravity sewer, complete 26 pipe spot repairs of various lengths, and rehab/repair of 194 manholes.

<u>Debt Requirement of the Project</u>: The projected capital cost of the 2022 Sewer Main Improvements Project is \$2,870,000, all of which is to be debt financed.

Means of Financing the Project: The project is to be financed through a State Reserve Project (SRP) loan at a maximum interest rate of 1.10% over 20 years, subject to availability and conditions of the funding program.

<u>Sources of Repayment for the Project</u>: The SRP loan principal and interest will be repaid using funds collected by the Town from its current customer base, through normal fees. Increases in these normal fees may be necessary in the near future but we anticipate such fees to remain below 4% of the Median Household Income for our service area (for those customers using 5,000 gallons per month or less).
