

Legislative Request

Session Law 2013-360, Section 7.8.

Notwithstanding any provision of law to the contrary, no contract for information technology personal services, or that provides personnel to perform information technology functions, may be established or renewed without written approval from the Statewide Information Technology Procurement Office and the Office of State Budget and Management. To facilitate compliance with this requirement, the Statewide Information Technology Procurement Office shall develop and document the following:

- (1) Standards for determining whether it is more appropriate for an agency to hire an employee or use the services of a vendor.
- (2) A process to monitor all State agency personal services contracts, as well as any other State contracts providing personnel to perform information technology functions.
 - (3) A process for obtaining approval of contractor positions.

Beginning October 1, 2013, the Statewide Information Technology Procurement Office shall report to the Joint Legislative Oversight Committee on Information Technology and the Fiscal Research Division on its progress toward standardizing information technology personal services contracts. In addition, the report shall include detailed information on the number of personal service contractors in each State agency, the cost for each, and the comparable cost (including benefits) of a State employee serving in that capacity rather than a contractor.

Assumptions and Methodology

Assumptions:

- This report is an update to the one submitted in December 2013 and will assume the reader is familiar with that report.
- Data in this report is current as of 3/15/14.
- For the purposes of this report, "Personal Services Contracts" are contracts entered into
 directly between an agency and an individual and satisfy "contract for information
 technology personal services" in the italics above. "Short Term Staffing" contract data is
 captured and being reviewed to satisfy the italicized legislation "contracts...that provide
 personnel to perform information technology functions."
- Per 09 NCAC 06B.1301, Personal Services Contracts for IT services have not historically been processed through Statewide IT Procurement. To gain visibility, ITS requested state



- agencies to provide information on current personal services contracts. The data included in this report is only as good as the agencies provided to ITS.
- ITS collected data from the ITS-managed Short Term Staffing (STS) Contract to capture similar information for contractors working to perform IT functions.

Methodology:

- 1. Methodology on equivalent cost is the same as the December report. Equivalent cost is for reference only until a more detailed job-by-job analysis can be completed. In many instances, contractors were hired to fill a short-term state employee gap, or to cover services for which no hires could be made because of salary discrepancies between market rate for a particular service and salary at which a state employee could be hired. The estimated cost of a state employee does not include the time and manpower required to create a position description, interview, hire, and all other associated administrative functions.
- This report is a snapshot in time. Until ITS, OSBM, and OSHR have opportunity to complete a thorough analysis of each individual situation, the potential savings should not be considered achievable.

Updates Since Last Report

IT Short-Term Staffing Contract and IT Personal Services Contract Approvals

Beginning in August, 2013, OSBM and ITS began approvals of all IT Contractor requests. The focus of the approvals has been on whether the request was associated with a project, hourly rate and length of request, confirmation of funds, alignment with strategy, and length the contractor has been on board. OSBM and ITS have worked agencies to identify the most appropriate conversion opportunities, and in many cases, contractor approvals were granted for 6 or 9 months only to allow the agency time to work with OSBM and OSHR to create a permanent position.

Short-Term Staffing Contract Strategic Sourcing Effort

In February, the IT Strategic Sourcing Division began a strategic sourcing effort for the IT Supplemental Staffing category. This category of services is covered primarily by the Short Term IT Staffing contract. The goals of the strategic souring effort are to improve cycle time and other process measures for staffing resources, implement supplier relationship management practices, and achieve cost savings by establishing market competitive rates.



These goals will be accomplished by implementing an operating model that is in line with industry best practices, which have been proven in both the public and private sectors. Preliminary indicators of opportunity suggest that the State could realize savings of 10-15% on hourly rates for IT Supplemental Staffing, assuming implementation of leading practices.

To date, the team has completed an internal profile, which includes spend and usage analysis, process documentation, and discussions with key customer agencies. ITS has also mobilized a cross-functional extended team of agency personnel to provide requirements and feedback throughout the strategic sourcing process. In addition, ITS has conducted a Request for Information (RFI) with the vendor community to solicit industry insights as well as North Carolina-specific recommendations. Collected requirements and industry expertise will be used to inform one or more competitive events to meet the State's IT Supplemental Staffing needs.

Updated Contract Information

Active Personal Services Contracts

Assumptions and considerations:

- 1. Data for Personal Services was provided by the agencies.
- 2. For the most part, the Personal Services engagements for IT are approved when they are short-term or only a small number of hours per month. These criteria are reflected in the low cost.
- 3. OSC contractors will be required to come through current approval process before renewal in June of this year. ITS and OSBM have engaged with OSC on the long-term nature of their Personal Services Contracts and will work to get permanent positions created by the end of the calendar year.
- 4. ITS and OSBM will continue to monitor and approval IT Personal Services Contracts when made aware of them.

Assumptions and considerations:

While the estimated FTE cost is intended to compare "apples to apples," there is difficulty in assuming that the state could hire a state employee to perform the service for the amount indicated. The cost difference versus the state also does not take into account time to post, recruit, interview, and process for new jobs. In some instances, the state paid less for Short Term Staffing rates than they would have paid a State employee. These costs appear negative in the table below.

Contractors Extended Since Last Report (11/15-13 – 3/15/14)

Assumptions and considerations:

- 1. While the estimated FTE cost is intended to compare "apples to apples," there is difficulty in assuming that the state could hire a state employee to perform the service for the amount indicated. The cost difference versus the state also does not take into account time to post, recruit, interview, and process for new jobs. In some instances, the state paid less for Short Term Staffing rates (where cost difference is negative).
- 2. Many extensions continue to be for the NC FAST project. Many of the DOT and OSC long-term contractor support positions have been for highly specialized SAP support, which is a known anomaly when compared to the state's pay scales in these areas.

Analysis

Types of Services most commonly employed

As in the last report, Computer Programming, Computer Systems Analysis, Project Management, and SAP Configuration make up the bulk of active IT contractors in the state. The first two categories have centered on NC FAST and DOT projects, while SAP assistance is regularly needed to configure DOT's SAP instance and to assist in planning the platform migration project. Project Management continues to be a significant need, and the state could save, on average, around \$50K per engagement if we were to hire more project managers in house. ITS will work with OSBM and OSHR to conduct a deep dive on this category of positions.



Appendix A – Calculation Methodology

Estimated FTE cost for a state employee equivalent was calculated as follows:

- 1. For the type of work being performed, ITS Human Resources identified the equivalent job category within the state
- 2. The Journey or Advanced Market Rate was identified for that job category
- 3. Added Social Security Benefit (7.5% of salary)
- 4. Added Retirement Benefit (14.7% of salary)
- 5. Added Medical Insurance (\$5285/year)
- 6. Compared hours of a state FTE to hours worked on the contract
