Executive Summary Economic Development Partnership of North Carolina Calendar Year 2021 Report to the North Carolina Department of Commerce

The contract relationship between the North Carolina Department of Commerce ("the Department") and the Economic Development Partnership of North Carolina, Inc. ("EDPNC"), a North Carolina nonprofit corporation, is entering its fifth year. Pursuant to the contract, the EDPNC agreed to operate as the sales and marketing arm of the State, responsible for: business recruitment, existing industry and small business support, import and export assistance, marketing, tourism, film and sports development.

Pursuant to the contract and N.C. Gen. Stat. § 143B-431A(e)(2), the EDPNC submits annual reports to Commerce, in which it outlines its program activities, objectives and accomplishments, as well as certain items specifically required by the enabling legislation. The report for calendar year 2021 is included in Attachment 2.

The chart below summarizes the key performance metrics from the 2021 calendar year compared to the previous three calendar years.

Over the past year, the leadership of the Department and the EDPNC have worked to strengthen relationships and enhance communications in an effort to improve collaboration between both organizations.

The EDPNC received significant funding from the NC General Assembly in the most recent budget including \$60 million for business and tourism marketing, \$1.5 million for a rural tourism recovery pilot program, \$50,000 for marketing and branding Eastern NC, \$125,000 for two new business counselors and \$1 million in recurring funds for the contract.

The Department will work closely with the EDPNC to make sure these new investments and its ongoing programs are implemented in a way that is consistent with the state's new strategic economic development plan, First in Talent.

The Economic Development Partnership of North Carolina respectfully submits herein its annual report for 2021.

Under its contract with the N.C. Department of Commerce, the EDPNC performs key economic development responsibilities on the state's behalf. These include recruiting new industry; supporting the growth of existing businesses; helping the state's manufacturers sell more exports; assisting startups; and promoting North Carolina as a premier destination for leisure travelers, retirees, amateur sports, and film and TV productions.

In 2021, despite the continued impacts of the Covid-19 pandemic, the EDPNC and our state and local partners successfully competed for 174 new corporate facility and expansion projects. Combined these announcements are expected to create 23,748 new jobs and over \$10 billion in new investment. The announced investment was the state's largest in any year on record, easily eclipsing 2020's historical level of inbound capital investment.

Just as importantly, announced recruitment and expansion projects spanned the diverse geography of our state, touching urban, suburban, and rural areas alike. Among other projects, North Carolina was fortunate to land multiple transformational investments in 2021. Apple announced plans for a 3,000-job, \$1 billion campus and engineering hub in Research Triangle Park in Wake County; Red Bull, Ball and Rauch are investing over \$1.1 billion with plans to hire 633 at a new beverage manufacturing campus in Cabarrus County; and Toyota Motor North America selected the Greensboro-Randolph County Megasite for a new \$1.29 billion, 1,750-job automotive battery manufacturing plant, it's first in North America.

Beyond these headline-grabbing projects supported by our Business Recruitment and Existing Industry groups, the EDPNC's other divisions contributed in their own ways to North Carolina's continued recovery from the pandemic:





- Our VisitNC tourism marketing team launched its "Get Back To A Better Place" advertising campaign,
 designed to engage would-be visitors cautiously resuming leisure travel plans after the first year of the
 global pandemic. Tourism spending indicators throughout the year suggest that though not yet back to the
 record levels set in 2019, visitor expenditures in the state during 2021 will represent a significant rebound
 from 2020.
- Our Existing Industry team provided support to 201 minority-owned and women-owned businesses across
 the state. These businesses were among the most affected by the pandemic, and our efforts centered on
 helping these firms understand available resources and programs to aid them in maintaining or growing
 their operations.
- Our International Trade team, which assists small and midsized manufacturers enter new markets around the world, helped 629 North Carolina businesses expand their customer base overseas. This was despite persistent challenges affecting international commerce, including continued travel restrictions.
- Our Small Business Advisory team provided technical assistance to more than 6,000 individuals and small businesses in the restaurant, retail, and hospitality sectors, given the pandemic's disproportionate impacts on these industries.
- Our Marketing & Research team commenced the first phase of its "All in North Carolina" business
 marketing campaign, aimed at touting the state's advantages not only to growing and relocating
 businesses, but also to technology and professional workers newly mobile thanks to the rise in remote
 work arrangements. This effort, bolstered by a state budget appropriation of \$30 million over the next three
 years, will generate even more business recruitment opportunities for the state, along with potentially
 attracting new human capital to move to North Carolina.

As you continue to say – and as we firmly believe – economic development in North Carolina is a team sport. The strength of the team effort that you have led this past year, and of which EDPNC is privileged to be a part, helped our state make great strides in the ongoing recovery led by Governor Cooper and including the North Carolina Department of Commerce, the General Assembly and regional and local economic development organizations.

PERFORMANCE RESULTS

Performance results by function are included in the tables appended to the end of this report. Where applicable, results are broken down by county, tier, and Prosperity Zone. All figures represent 2021 results except for visitor spending and tax revenues in Appendix C, which represent 2020 results due to a lag in data availability. Visitor spending and tax revenues for 2021 will be available in late Spring of 2022.

SALARIES AND COMPENSATION

The Economic Development Partnership of North Carlina considers several factors in determining employee salaries, including the level of performance, knowledge, experience, years in industry and supervisory skills of the employee (or candidate), as well as market conditions for the position.

In addition to their salaries, EDPNC employees can receive performance-based compensation based on divisional and individual performance during a full calendar year. The plan enables the EDPNC to pay an employee performance-based compensation ranging from zero to up to 18.75 percent of his or her gross annual salary.

The EDPNC's executive leadership and board of directors crafted the plan to increase employee accountability and reward strong performance, particularly for achievements that increase economic development in the state's rural and low-income areas. All full-time employees and regular part-time employees are eligible to participate in the plan, which is funded by EDPNC's private funds.

Under the performance-based compensation plan, each EDPNC business unit is allotted a portion of an organization-wide compensation pool, based on the unit's overall performance relative to certain key performance indicators (KPIs). Business unit employees are eligible for compensation out of the department's allotment. Wherever applicable, the performance metrics determining an employee's performance-based compensation assign a weight to work that creates announced jobs and capital investment in Tier 1 and Tier 2 counties.

Encouraged by a 2019 report completed by the Program Evaluation Division of the NC General Assembly, the EDPNC board of directors commissioned an outside firm to assess EDPNC's compensation and benefits relative to market, and to review EDPNC's performance-based compensation plan. A committee of the board reviewed findings of the report and worked with EDPNC's executive leadership and human resources personnel to revise the organization's compensation model, including a reduction in performance-based compensation eligibility, capped at 6.25%, for non-sales positions. The revised plan went into effect beginning January 2021.

FY2020-2021 FINANCIALS

The EDPNC strives to attract jobs and capital investment to North Carolina while using limited resources efficiently.

In fiscal year 2021, running from July 1, 2020, through June 30, 2021, the partnership received \$39,889,001 in total revenue and had expenses totaling \$38,530,372. The EDPNC's funding sources for FY 2021 included the state of North Carolina contract (\$18,835,966 in state funding); state payments from federal COVID relief funds to support tourism and business marketing and other federal grant revenues (\$18,430,264); private fundraising revenue (\$1,183,627); and other revenues (\$340,544). Itemized expenses for the year included personnel (\$6,843,259); advertising and promotion (\$27,977,077); professional fees, including contracts with foreign trade offices (\$1,785,894); travel and hospitality (\$115,302); facilities and utilities (\$754,228); information technology (\$292,020); and other general office expenses (\$225,253).

A copy of the audited financials for EDPNC's fiscal year ended June 30, 2021, has been provided to the Joint Legislative Economic Development and Global Engagement Oversight Committee, the NC Department of Commerce, and the Fiscal Research Division of the North Carolina General Assembly.

FUNDRAISING

Despite a challenging fundraising landscape due to continued effects of the pandemic, fifty-eight companies, organizations and individuals invested in the EDPNC in calendar year 2021, supporting key efforts to market the state for business relocations and expansions, tourism and film productions.

The EDPNC raises non-state investment to supplement its state funding. During the seventh year of the contract with the Department of Commerce, running from Jan. 1, 2021 through Dec. 31, 2021, the EDPNC raised \$1,397,655 in non-state funds and in-kind donations.
