Transition from NC Rural Center

- Rural Economic Development Division created July 2013 by NC General Statute 143B-472.126
- With the creation of the Rural Economic Development Division, the NC Rural Center grants were transferred to the Department of Commerce Rural Division
- 510 previously awarded grants (previous to July 2013) with a balance of over \$72 Million transferred to the Rural Division to manage
- 204 grants remain active with a balance of \$24M to disburse



Remaining at NC Rural Center

The NC Rural Center operates multifaceted programs with four overarching goals:

- Serve as the state's rural policy leader and advocate
- Develop strategies to bring about economic and social transformation
- Equip rural leaders to succeed in the 21st century through leadership programs
- Deliver resources for rural people, businesses and communities

No state funds are appropriated for any programming



Public Infrastructure

RURAL ECONOMIC INFRASTRUCTURE CDBG-ECONOMIC DEVELOPMENT UTILITY FUND

Eligible projects include but are not limited to:

- Upgrades or repair of public drinking water or wastewater treatment plants
- Upgrades, extensions, or repair of public water or sewer lines
- Natural gas infrastructure
- Demolition of dilapidated buildings to create good sites
- Installation or extension of public broadband infrastructure
- Access roads
- Construction of public rail spur improvements





CDBG-Economic Development Site Development & Shell Building Loans

Site Development Loan

- Must be offered to prospective industrial users only
- Maximum of \$4,000,000 to local government in Tier 1 & 2
- Maximum of \$3,000,000 to local government in Tier 3
- Eligible loan calculated on projection of \$35,000 per job created by eventual business locating on site
- 2% simple interest with a seven-year term
- Interest only payments in years one and two

Shell Building Loan

- Must be offered to prospective industrial users only
- Maximum of \$1,000,000 to local government Tiers 1, 2, 3
- Eligible loan calculated on projection of \$35,000 per job created by eventual building occupant
- 2% simple interest with a five-year term
- Interest only payment in years one and two

Appalachian Regional Commission Community Support & Grants

A 13-state-federal partnership that serves 29 of the western counties with flexible program spending including workforce training, educational opportunities, road access and other infrastructure.

Approximately \$3M available in grant funds for FY16

Approximately \$9M awarded 2013-2015

Downtown economic development within the context of historic preservation, using a comprehensive approach to downtown revitalization developed by the National Trust for Historic Preservation

The **Commerce Fellows / Building Community through Capacity and Knowledge** program is a collaboration among the NC Department of Commerce Rural Economic Development Division CDBG program, East Carolina University (ESU) and UNC-Chapel Hill School of Government (UNC SOG) to provide professional development opportunities in Development Finance Tools, Economic Development Strategies, Effective Supervisory Leadership, Public Records Law, Human Capital Matters, and County and Municipal Administration.





Special Projects

Broughton Hospital Property Study in Burke County

- A collaborative project between the Department of Commerce, Department of Administration and Department of Health & Human Services
- Partnering with Development Finance Initiative (DFI) at the School of Government to study potential redevelopment of the Broughton Hospital properties when vacated, as well as the contiguous state-owned properties

Seymour Johnson Air Force Base – Joint Land Use Study

 A collaboration between the NC Department of Commerce Rural Division and the Office of Economic Adjustment / US Department of Defense. The JLUS will address compatibility planning in the northeast NC region. The primary objective is to reduce conflicts between Seymour Johnson Air Force Base/Dare County Range and areas affected by operations while accommodating new growth and economic development, sustaining economic vitality, protecting public health and safety, and sustaining the operational missions of the base.



Areas for Opportunity

- Reorganized Division to better serve communities
