Natural Gas Industry Structure

- Three parts of natural gas industry
 - Exploration and Production (E&P)
 - Interstate pipelines and storage facilities
 - Local Distribution Companies (LDCs)
- E&P companies are not price-regulated
- Interstate companies are regulated by FERC (Federal Energy Regulatory Commission)
- LDCs are regulated by state commissions

- 4 Local Distribution Companies (LDCs) in the state
 - Piedmont Natural Gas Company, Inc.
 - PSNC Energy
 - Frontier Natural Gas Company, LLC
 - Toccoa Natural Gas
- 1 Intrastate Gas Pipeline (Cardinal Pipeline Company, LLC)
- 8 Municipal Gas Systems rates not regulated by the Commission
- 1 Interstate Gas Pipeline (Transco) crosses the State
 - 2 others (Columbia and Patriot) provide small volumes
 - Atlantic Coast Pipeline (in planning/permitting)
- 1 interstate liquefied natural gas storage facility (Pine Needle LNG Company, LLC)








Natural Gas Customers in NC




Major Local Distribution Companies' Number of Customers (As of 6/30/17)
