- Expansion Project: \$5,966,206.00
- Grant awarded by the US DVA Cemetery Grant Program
- Construction Phase
- On site working tree removal is underway. Silt fence being installed. Discussing storm drain connections and location. Reviewing demo if existing road network and design of new road system
- Designer is on site weekly
- Contractor: Engineered Construction Co Raleigh NC

Western Carolina Veterans Cemetery (Black Mountain)

- Expansion Project: \$3,028,255.00
- Grant awarded by the US DVA Cemetery Grant Program
- Construction Phase
- Pre-Construction meeting held October
- Contractor began work 01 November 2018.
- Contractor: Tennoca Construction Company Candler, NC

NC State Veterans Home – Wake

Projected Cost – \$38,890,800.00 Trust Fund Match 35% – \$13,611,780.00

- Designs are under review by SCO

NC State Veterans Home – Guilford

Projected Cost — \$38,890,800.00 Trust Fund Match 35% — \$13,611,780.00

Escheats Scholarships Funds

- Senate Bill 125 Section 6.4 Restores \$2.4m (non-recurring) to the Children of Wartime Veterans
 Scholarship program. Funding was reduced by 25% in 2013.
- Funding was requested in Gov. Cooper's budget to restore room and board allowance.
- Funds used to restore room and board allowance to Class II and Class III competitive scholarships.
- Based on available funding provided, the room rate is now \$4,000.00 and the board rate is \$2,400.00 per year per student.
- Requesting (\$2.4m) funding be recurring so the new rates will be sustained due to ever-increasing cost of higher institution education.
