#### **COLLECTIONS CASE MANAGEMENT STATUS**




### Purpose

- Budget \$20m one time, \$5m recurring
- Purpose
  - The current collections systems are proprietary and the original system architects have retired. Any malfunction in the current systems could potentially reduce the collection of over \$600m annually.
  - Obtain and implement a workflow based system to support collections activities.
  - Stop the annual growth of Accounts Receivable (~\$200m FY19-20)
  - Reduce the total Accounts Receivable (~\$1.5B FY19-20)

#### **Brief Timeline**

- Request for Proposal (RFP) was sent to Department of Information Technology (DIT) on July 25, 2017 and posted on January 22, 2018.
- March 1, 2018, only one responsive submission was received. RFP was canceled.
- New RFP was posted on August 14, 2018.
- November 19, 2018 NCDOR received eight responsive submissions.



### **Timeline**

- Contract was awarded March 13, 2020
- ZPGroup protested the award March 26, 2020.
- DIT legal recused themselves from the protest and referred the case to Administrative Office of Administrative Hearings (OAH).
- Contract was canceled on August 17, 2020.



### Next Steps


- Reviewing off-the-shelf software that may be suitable
