WHAT IS NC ePROCUREMENT?

NC ePROCUREMENT IS THE STATEWIDE PURCHASING SYSTEM, WHICH PROVIDES THE TOOLS TO IMPROVE THE WAY THE STATE OF NORTH CAROLINA PURCHASES GOODS AND SERVICES.

NC eProcurement...

Offers an **innovative**, **cost-saving**, and **efficient** method of purchasing.

- Was initiated through a creative public private partnership between Accenture and the State that started in 2001
- To date, all costs, including the implementation services, hardware, and software for the system, as well as ongoing operations have been fully funded through the eProcurement Fee
- The eProcurement Fee was set in 2001 at 1.75% of the value of goods purchases only, assessed to the Vendors supplying the goods
- The 1.75% eProcurement Fee now provides the State with an ongoing source of revenue to support procurement more broadly, in addition to continuing to fund the eProcurement System operation


ePROCUREMENT STATISTICS AT A GLANCE

NC EPROCUREMENT HAS BEEN A SUCCESSFUL AND TRULY ENTERPRISE INITIATIVE FOR THE STATE.




NC ePROCUREMENT MODULES

SAP Ariba Buying	Single, enterprise-wide, web-based purchasing system that offers electronic purchase order processing and enhanced administrative functions to buyers and suppliers, resulting in operational efficiencies, cost savings, and strategic procurement information
SAP Ariba Contracts	Supports the creation, execution, and management of contractual agreements negotiated by State agencies
SAP Ariba Sourcing	Allows State agencies to electronically create, manage, and award sourcing events

Transition Billing and BillPrep applications to cloud	Transition the Oracle E-Business Suite (EBS) billing application and custom BillPrep applications that manage the billing and collection of eProcurement fee to the cloud
Ariba Supplier Lifecycle and Performance (SLP)	Implementation of SAP Ariba Supplier Lifecycle and Performance (SLP) module to interface with new Vendor Portal to capture vendor qualifications
Interface with OSC Financial Backbone Replacement	Design, develop, test and implement the interface between NC eProcurement and the new Financial Backbone Replacement (FBR) system
