# Study Objectives

• Determine if the way North Carolina (NC) shares responsibility for Education, Public Welfare, Health, and Transportation services is different from comparable States.

# Study Questions

- What is the percent distribution of responsibility sharing between NC State government and NC local governments?
- What is the average percent distribution of responsibility sharing between comparable State governments and their local governments?

## Definition of Comparable States

- States with the same or close to the same Expenditure Need per Capital as NC, and/or
- States with the same or close to the same (i.e. + or -3% difference from NC's)
   Expenditure Need Index as NC

## **Education Services**

- The structure of education service responsibility sharing between NC's state government and its local government is similar to that of comparable states.
- NC's 35% is close to the average of 32%
- Four states assume more responsibility while six states assume less responsibility

## Public Welfare Services

• Include: cash assistance payments, vendor payments, and public employment for all public welfare activities and expenditure for welfare not classified elsewhere.

## Public Welfare Service

- The structure of public welfare service responsibility sharing between NC's government and its local governments is similar to that of comparable states.
- North Carolina's 86% is close to the average of 92%
- However, eight states assume responsibility for over 93% of total spending

# Health and Hospital Services

- Hospital care in other hospitals (public or private) and support of other public and private hospitals;
- Financial support of other public or private hospitals, including construction; payments to private corporations who lease and operate government-owned hospitals; and construction of hospitals to be leased or turned over to others to operate.
- Other public health programs

## **Transportation Service**

- North Carolina assumes a greater share of responsibility (78%) than similar states (54%)
- Only West Virginia assumes a higher percent of responsibility at 90%

### **Environment and Housing Services**

- North Carolina's 30% is higher than most states.
- Nine states share 25% or less of the total burden
- Only West Virginia and Kentucky share a greater percent of the burden

- There is wide disparity in the share of funding in this area ranging from North Dakota's 12% to Kentucky's 65%.
- North Carolina's 40% is close to the average of 43%

### **Insurance Trust Services**

• Ten of the eleven states assume at least 74% of the responsibility for these payments with six states (including North Carolina) assuming at least 95% of the costs
