

COMMITTEE ON COMMON CORE STATE STANDARDS (LRC) (2013) March 20, 2014 Room 643

The Committee on Common Core State Standards (LRC) (2013) met on Thursday, March 20, 2014 at 10:00 am. The meeting was held in Room 643. Members present were: Representatives Bryan Holloway (Co-Chair), Tim Moore, Marcus Brandon, Jeffrey Elmore, D. Craig Horn, Larry Pittman, Michael Speciale; Senators Dan Soucek (Co-Chair), Chad Barefoot, Warren Daniel and Jerry Tillman.

Senator Dan Soucek presided and called the Public Hearing to order. First order of business was approval of the February 20, 2014 minutes. Motion for approval was made by Representative Craig Horn.

Senator Soucek thanked the audience for being present. Also, thanks was given to President Pro Tem Phil Berger and Speaker of the House Thom Tillis for the comprehensive LRC study.

Senator Soucek stated to the audience that the committee has received a tremendous amount of comment from around the state and information received from other states. He further commented that there are several different roles in government and standards are viewed both constitutionally and legislatively. The Department of Public Instruction and the State Board of Education play vital roles throughout the history of our state. Senator Soucek elaborated that as the committee moves forward a sense of certainty remain intact for effective and efficiency throughout all governmental agencies involved. He commented that as legislators and elected officials our responsibility is to examine all of these measures. He stated that the education of our children is the most important thing we do in North Carolina State Government.

Representative Holloway echoed Senator Soucek and commented that this is something new for the General Assembly. He commented that Common Core came about several years ago and is responsible for placing the standards in K-12 education.
