Drug offenses And Sentencing Laws

Uniform Controlled Substances Act in 1970

Elements of the Act

Controlled substance schedules Base offenses Additional offenses **Penalties** Trafficking offenses

Non-Trafficking Offenses

Conduct

- Base offenses Manufacture, sell, deliver, possess with intent, or possess
- Additional offenses other elements (e.g., involving a minor)

Classification

- Based on conduct and schedule of the substance or a specific substance
- Attempt and conspiracy same class as underlying offense

Sentencing

- Non-trafficking offenses are sentenced under Structured
 Sentencing
 - Based on the class of the offense and the offender's prior record level
 - Judge determines type of sentence and length of sentence

Conditional Discharge for First Offense

- G.S. 90-96(a) and (a1)
- No prior convictions
- Guilty of possession
- No judgment, defendant is placed on probation
- Violation results in sentencing, successful completion results in dismissal

Trafficking Offenses

- Conduct
 - Sell, manufacture, deliver, transport, or possess
- Classification
 - Based on substance and amount
- Conspiracy to traffic
 - Same class and sentence

Sentencing for Trafficking Offenses

Mandatory active sentence


Class	Minimum	Maximum
С	225 months	282 months
D	175	222
E	90	120
F	70	93
G	35	51
Н	25	39

Exceptions

- Attempt to traffic
 - Same class, Structured Sentencing sentence
- Substantial Assistance
 - Shorter sentence and/or suspended sentence


Sentencing Data for Drug Offenses

Felony Convictions





Non-Trafficking Drug Convictions





Active Rates - Felony and NTD Convictions






Active Rates - Misdemeanor and Drug Convictions


Drug Trafficking (DT) Convictions
